<u>HB 2101</u> <u>(HSCR78-10)</u> <u>Status</u>	RELATING TO CUSTOMER SERVICE. Directs the ombudsman to develop and implement a pilot program using informed customers to investigate customer service at state agencies.	LAB, LMG, FIN
<u>HB 2276</u> <u>(HSCR68-10)</u> <u>Status</u>	RELATING TO PUBLIC SAFETY. Requires bills to amend or create new offenses, or to change parole or probation procedures, to be accompanied by a correctional impact statement. Requires assistance of the corrections population management commission to prepare corrections population impact.	PBS, LMG, FIN

DECISION MAKING TO FOLLOW
