<u>SB 2213</u>	RELATING TO COUNTIES.	TIA/PSM, WAM
<u>Testimony</u>	Provides that each county has the power to establish medical marijuana dispensaries. Requires that medical marijuana dispensaries shall only provide service to qualified patients and primary caregivers registered with the department of public safety. Makes dispensaries subject to the general excise tax by making inapplicable the exemption for amounts received from sales of prescription drugs or prosthetic devices.

<u>SB 2504</u>	RELATING TO CARGO INSPECTIONS.	TIA/PSM, WAM
<u>Testimony</u>	Requires the state departments of defense and transportation to develop a plan to increase the random inspection rate of incoming cargo into the State to 10% by 1/1/13 and to 25% by 1/1/15. Also requires a report to the legislature.

<u>SB 2550</u>	RELATING TO FIREWORKS.	PSM/TIA
<u>Testimony</u>	Clarifies definition of consumer fireworks; adds definition of consumer novelty fireworks; prohibits novelty fireworks; clarifies requirements for permits.
