Requires the department to provide annual data regarding acts of sexual assault and sexual misconduct. Requires the department to report to the Legislature on any implementation of the federal Prison Rape Elimination Act. Effective July 1, 2020. (HB2266 HD1)	PSM, WAM
<u>HB 415, HD2</u> <u>(HSCR490-10)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PUBLIC SAFETY. Directs the auditor to conduct a financial and management audit of the Department of Public Safety's contract with the Corrections Corporation of America and the federal detention center in Honolulu. Effective December 21, 2020. (HB415 HD2)	PSM, WAM
<u>HB 2657, HD1</u> <u>(HSCR622-10)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PUBLIC SAFETY. Requires the department of public safety to plan for a model wellness center on State land. Report to legislature in 2011. Effective July 1, 2020. (HB2657 HD1)	PSM, WAM
<u>HB 2383, HD1</u> <u>(HSCR470-10)</u> <u>Testimony</u> <u>Status</u>	<u>RELATING TO FLAGS.</u> <u>Recognizes and allows the prisoner of war/missing in action flag to be flown with the U.S. and Hawaiian flags on specified days. (HB2383 HD1)</u>	<u>PSM, JGO</u> <u>[Measure added on 03-10-10]</u>
