<u>HB 2439</u> Status	RELATING TO TAXATION. Creates a 10% refundable tax credit for construction or renovation costs incurred on a qualified hotel facility before December 31, 2015.	TCI/EBM, FIN
<u>HB 2681</u> Status	RELATING TO TAXATION. Provides until 12/31/11, a tax credit for hotel construction and renovations.	TCI/EBM, FIN
<u>HB 2559</u> Status	RELATING TO REMODELING TAX CREDITS. Provides a ten percent tax credit on costs incurred for the construction or renovation of a hotel or resort property through December 31, 2012.	EBM/TCI, FIN


