<u>SB 2502</u> <u>(SSCR2106)</u> <u>Testimony</u> <u>Status</u>	MAKING AN APPROPRIATION TO THE HAWAII CIVIL AIR PATROL FOR OPERATING EXPENSES. Appropriates funds to the Hawaii civil air patrol for tsunami operations in Hawaii.	PSM, WAM
<u>SB 2533</u> <u>(SSCR2105)</u> <u>Testimony</u> <u>Status</u>	RELATING TO AN AUDIT OF CONTRACTS OF THE DEPARTMENT OF PUBLIC SAFETY WITH THE CORRECTIONS CORPORATION OF AMERICA AND THE FEDERAL DETENTION CENTER. Directs the auditor to conduct a financial and management audit of the Department of Public Safety's contract with the Corrections Corporation of America.	PSM, WAM
