Requires moneys to be deposited into the county general fund for the county that issued the fine or if the fine is issued by the state, into a special account in the state general fund for use by the state law enforcement agency that issued the littering citation. <u>SB 2544, SD1</u> <u>(SSCR2085)</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST HONOLULU SEAWATER AIR CONDITIONING LLC PROJECTS ON THE ISLAND OF OAHU. Extends the authorization to issue special purpose revenue bonds for Honolulu Seawater Air Conditioning LLC. (SD1)	ENE, WAM
