<u>SB 2061, SD1</u> <u>(SSCR2098)</u> <u>Testimony</u> <u>Status</u>	RELATING TO PROCUREMENT. Permits bidders and their subcontractors who are registered under an apprenticeship agreement with DLIR to benefit from a 5% reduction in their bid amount on contracts for \$250,000 or more. Effective 7/1/2050. (SD1)	LBR/JGO, WAM
<u>SB 2107, SD1</u> <u>(SSCR2047)</u> <u>Testimony</u> <u>Status</u>	RELATING TO HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND. Conforms to medicare law the definition of "dependent-beneficiary" in the employer-union health benefits trust fund law relating to disabled individuals. (SD1)	LBR, WAM
<u>SB 2205, SD1</u> <u>(SSCR2059)</u> <u>Testimony</u> <u>Status</u>	RELATING TO EMPLOYER-UNION HEALTH BENEFITS TRUST FUND. Allows individual beneficiaries enrolled in a Hawaii employer-union health benefits trust fund health benefits plan to opt out of any requirement to purchase prescriptions by mail order. (SD1)	LBR, WAM
<u>SB 2324, SD1</u> <u>(SSCR2316)</u> <u>Testimony</u> <u>Status</u>	RELATING TO UNEMPLOYMENT INSURANCE BENEFITS. Authorizes an individual that is attached to a regular employer who is not offering work to still receive unemployment insurance benefits under certain circumstances if the individual separates from an employer offering part-time employment. (SD1)	LBR, WAM
<u>SB 2393, SD1</u> <u>(SSCR2127)</u> <u>Testimony</u> <u>Status</u>	MAKING AN APPROPRIATION FOR COLLECTIVE BARGAINING COST ITEMS. Appropriates moneys to fund collective bargaining cost items relating to the employer contributions to the Hawaii employer-union health benefits trust fund. (SD1)	LBR, WAM

<p><u>SB 2549, SD1</u> <u>(SSCR2317)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO EMPLOYMENT SECURITY. Amends the appropriation from the UI trust fund and the amounts allocated to the workforce investment boards on the islands of Oahu, Maui, Kauai, and Hawaii; amends the appropriation to be used by the workforce development council; repeals the appropriation allocated to the department of labor and industrial relations for administrative expenses. Effective 7/1/2050. (SD1)</p>	<p>LBR, WAM</p>
<p><u>SB 2691, SD1</u> <u>(SSCR2130)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO THE PAYMENT OF EMPLOYEES' RETIREMENT SYSTEM BENEFITS. Requires by March 1, 2011, all retirees and beneficiaries of the ERS to designate a financial institution account into which retirement benefit may be deposited. (SD1)</p>	<p>LBR, WAM</p>
<p><u>SB 2840, SD1</u> <u>(SSCR2277)</u> <u>Testimony</u> <u>Status</u></p>	<p>RELATING TO PUBLIC PROCUREMENT. Requires at least eighty per cent of workers on certain public works contracts and construction procurements to be Hawaii residents. (SD1)</p>	<p>LBR/JGO, WAM</p>
<p><u>SB 2884, SD1</u> <u>(SSCR2129)</u> <u>Testimony</u> <u>Status</u></p>	<p>MAKING AN APPROPRIATION FOR COLLECTIVE BARGAINING COST ITEMS. Appropriates moneys to fund collective bargaining cost items for collective bargaining unit (10) relating to the employer contributions to the Hawaii employer-union health benefits trust fund. (SD1)</p>	<p>LBR, WAM</p>
