<u>SB 1601, SD1</u> <u>(SSCR2337)</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE LAND USE COMMISSION. Requires that one member of the land use commission be a farmer. (SD1)	WTL
<u>SB 2340</u> <u>Testimony</u> <u>Status</u>	RELATING TO KANEOHE BAY REGIONAL COUNCIL. Requires the Kaneohe Bay Regional Council to meet annually instead of quarterly and to report on its activities annually instead of semi-annually. Repeals the sunset of the Council scheduled for 7/1/2010.	WTL
<u>SB 2547</u> <u>Testimony</u> <u>Status</u>	RELATING TO SMALL BOAT HARBORS. Requires small boat harbor commercial vessel permittees who, in the course of providing an excursion between state boating facilities, disembark fare-paying passengers with the expectation that they will enter upon any public or quasi-public real property during the course of their excursion, to comply with all rules and regulations applicable to these areas.	WTL
<u>SB 2914</u> <u>Testimony</u> <u>Status</u>	RELATING TO THE BUREAU OF CONVEYANCES. Requires registrar to provide adjoining landowner, upon request, any information of record relating to the management, control, and title of any public highway, waterway, or water course.	WTL
<u>SB 492</u> <u>Proposed SD1</u> <u>Testimony</u> <u>Status</u>	RELATING TO WATER. Proposed SD1: Requires that the commission on water resource management include one member from each county and that at least one member be a farmer. (SD1)	WTL

- In person: 1 copy of their testimony to the committee clerk, Room 228, State Capitol.
- By fax: Testimony may be faxed if less than 5 pages in length, to the Senate Sergeant-At-Arms Office at 586-6659 or 1-800-586-6659 (toll free for neighbor islands), at least 24 hours prior to the hearing. When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.\
- LATE TESTIMONY – Testimony received after the testimony deadline will be posted on the legislature's website after the hearing ends. If you are testifying in person, please bring twelve (12) copies of your testimony to the hearing room (229) and give to the committee clerk PRIOR to the start of the hearing

Please note: If you submit your written testimony after 3:00 p.m. the day prior to the hearing, please sign-in at the staff table to testify orally. A copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.

If you require special assistance or auxiliary aids or services to participate in the public hearing process (i.e., sign or foreign language interpreter or wheelchair accessibility), please contact the committee clerk 24 hours prior to the hearing so arrangements can be made.
