HB 2383 Status	RELATING TO FLAGS. Recognizes and requires the prisoner of war/missing in action flag to be flown with the U.S. and Hawaiian flags.	EBM, JUD
HB 2804, HD1 (HSCR116-10) Status	RELATING TO CHILD SUPPORT ENFORCEMENT. Authorizes the child support enforcement agency to receive and investigate complaints of the misuse of child support. Provides that complaints may be filed by the child for whom child support is ordered or by a guardian ad litem. (HB2804 HD1)	HUS, JUD
HB 2349 Status	RELATING TO VIOLENCE AGAINST HEALTH CARE PERSONNEL. Extends protection from assault and terroristic threatening to emergency room personnel.	HLT, JUD
SB 466, SD2, HD1 (HSCR1287) Status	RELATING TO POLLUTION. Prohibits the use of leaf blowers on or near residential zones, except within allowed time periods. Prohibits leaf blowing operations from blowing debris onto adjacent property without permission. Prohibits certain other actions related to leaf blowing. (SB466 HD1)	EEP, JUD
HB 2020, HD1 (HSCR9-10) Status	RELATING TO COUNTIES. Expands county enforcement of traffic regulations on public streets, roads, or highways whose ownership is in dispute between the State and the county, and on private streets, highways, or thoroughfares, to include laws relating to county vehicular taxes, motor vehicle safety responsibility, traffic violations, use of intoxicants while operating a vehicle, motor vehicle insurance, motorcycle and motor scooter insurance, and odometers. (HB2020 HD1)	TRN, JUD
HB 2284 Status	RELATING TO REAL PROPERTY. Extends repeal date of Act 189, SLH 2009, to 6/30/2010.	EBM, JUD
HB 1942, HD1 (HSCR100-10) Status	RELATING TO VETERANS COURT. Establishes a temporary Hawaii Veterans Court within the Judiciary to help address prison overcrowding. (HB1942 HD1)	EBM, JUD, FIN

Status	Excludes non-violent offenders from repeat offenders statute requiring mandatory minimum prison terms.

HB 2846	RELATING TO KAKAAKO.	WLO/HSG
Status	Increases the reserved housing requirement for a major development on a lot of at least 1 acre in the Kakaako community development district, mauka area. Requires the Hawaii community development authority to adopt or amend rules.	

HB 2849	RELATING TO KAKAAKO.	WLO/HSG
Status	Imposes reserved housing requirement for residential and commercial planned development permit projects greater than 45 feet in height or containing a floor area ratio greater than 1 1/2 on a lot 20,000 square feet or greater in size in the Kakaako community development district, mauka area.	

HB 2918	RELATING TO KAKAAKO COMMUNITY DEVELOPMENT DISTRICT.	WLO/HSG
Status	Enables the Hawaii Community Development Authority to enter into development agreements.	

HB 1882	RELATING TO SHORELINE SETBACK.	WLO
Status	Prohibits inclusion of accreted lands in determining shoreline setback line in counties with population over 500,000.
