State Fiscal Stabilization Fund (SFSF)

Update: ARRA Title I

\$33,171,874

- **\$14,435,266 allocated for Extended Learning Opportunities (ELO); \$5,051,225 remains for intersessions and summer 2011**
- **\$100,000 allocated to be spent on federal reporting (admin)**
- **\$3,317,447 allocated to be spent on PD to implement Common Core Standards, Data for School Improvement, and School Dashboards**
- **\$16,587 allocated to be spent on parent participation activities as recommended by current research project**



Update: ARRA Title I (continued)

- **\$1,326,979 allocated to support Title I schools ineligible for Race to the Top or School Improvement grants**
- **\$563,966 indirect costs allocated and spent**
- **\$158,341 allocated for private school partners needing funds SY2010-11 and summer 2011**
- **Approximately \$13 m. are planned for allocation to various Complex Areas to fund their plans for improving student achievement and growth to eligible students/schools to fund their plans for improving student achievement and growth to eligible students/schools.**

Update: ARRA IDEA

\$39,925,269

- **\$19,962,625 allocated and expended for services to eligible students**
- **\$100,000 allocated for administration, and will be expended on federal reporting protocols**
- **\$191,464 allocated and will be expended as requested by private school partners**
- **\$5,500,000 allocated for Response to Intervention (RTI); funds will cover RTI resource teachers, training, and resource tools**
- **\$4,200,200 allocated for computers, almost all expended**
- **\$3,900,000 allocated and expended on teacher supplies**

Plans are being formulated for the remaining \$5,010,102.

Update: State Education Technology Grant

\$3,209,375

- **\$ 2,994,347 allocated and expended to develop and deploy instructional technology systems which facilitate standards-based instruction and assessment; the remaining \$387,042 will be expended on professional development**
- **\$215,028 allocated for SEA activities; some of remaining \$115,789 will be available to private school partners for student achievement through technology**

Updates

Special Education Preschool

- **\$1,061,069 allocated; \$149,295 remaining**

Education for the Homeless (McKinney-Vento)

- **\$175,966 allocated; \$ 59,681 remaining**

Child Nutrition Program

- **\$348,600 allocated; \$6,924 remaining**

ARRA School Improvement Grants (SIG)*

\$9,312,839

SIG funds are directed to improve achievement at six identified schools to assist them in making AYP and exiting improvement status. These “priority schools” are also part of the Race to the Top plan for struggling schools.

Budget:

Year 2	\$3,603,500
Year 3	\$3,058,713

***ARRA SIG funds of \$9,312,939 will be augmented by non-ARRA SIG funds of \$1,694,018.**
