## RELATING TO INTOXICATING LIQUOR VIOLATIONS INVOLVING MINORS.

Establishes an immunity from prosecution for consumption of intoxicating liquor by a minor if the minor summons medical treatment for another minor who requires such treatment as a result of consuming liquor. Also applies to the intoxicated minor and one or two other minors assisting the summoning minor. (SD1)

# RELATING TO ENVIRONMENTAL PROTECTION. Requires businesses in the State to distribute only reusable or biodegradable checkout bags. Effective 7/1/50. (SD2)

# SB2570, SD1 PROPOSING AN AMENDMENT TO ARTICLE X, SECTION 2, OF THE HAWAII CONSTITUTION, TO CHANGE THE BOARD OF EDUCATION FROM AN ELECTED BOARD TO

Proposes a constitutional amendment to require voting members of the board of education to be appointed by the governor, with the advice and consent of the senate, as provided by law. (SD1)

### RELATING TO CHARTER SCHOOLS.

EDN, FIN

Requires the Department of Education to make available vacant school facilities or portions of school facilities for use by charter schools. Requires the charter school review panel to compile a prioritized list of charter schools that wish to use vacant school facilities or portions of school facilities. Makes changes to charter school funding. Requires the Charter School Review Panel (CSRP) to determine a clear process with rigorous criteria for the reauthorization of charter schools. Requires the CSRP to reauthorize charter schools no later than four years following the initial issue of the charter, and every four years thereafter. Requires the Charter School Administrative Office (CSAO) to withhold funds for its operational expenses, subject to certain requirements. Requires the CSAO to report annually to the CSRP individual and aggregate operational and instructional expenditures of charter schools. Requires per-pupil allocation checks paid by the CSAO to individual charter schools to be cosigned by the executive director of the CSAO and an agent of the CSRP. Repeals the cap on the number of charter schools. Effective 7/1/2050.

## RELATING TO THE SECURE AND FAIR ENFORCEMENT FOR MORTGAGE LICENSING ACT.

CPC/JUD, FIN

Makes amendments to the application, licensing, and regulatory requirements of the Secure and Fair Mortgage Licensing Act. Establishes the mortgage recovery fund to protect consumers injured by violations of chapter 454F, HRS. Includes mortgage loan originator companies in the regulatory system established by chapter 454F. Authorizes the commissioner of financial institutions to hire temporary and permanent staff to effectuate the purposes of chapter 454F, HRS. (SD2)

### SB2617, SD1

### RELATING TO PUBLIC AGENCY MEETINGS.

JUD, FIN

Amends the notice requirement of public agency meetings to allow for notification of meetings and transmittal of meeting minutes by electronic mail. Requires concurrence from office of information practices rather than the attorney general for board to hold emergency meeting for unanticipated events. Requires executive meetings of boards to be properly noticed, and requires subject matter and discussion in an executive meeting

### SB2625, SD2 RELATING TO OUT-OF-STATE OFFICES.

EBM, LMG, FIN

Beginning July 1, 2010, requires at least every two years an audit of the department of business, economic development, and tourism's out-of-state offices; repeals exemption from audit and accounting requirements for out-of-state offices; beginning February 1, 2010, requires the department to cease expending or transferring any remaining federal reimbursement market development cooperator program funds; requires the department to update policies and procedures of the out-of-state offices; requires the state procurement office to review financial records of the 2005 trade mission; requires reports to the legislature.

### <u>SB2626, SD1</u> RELATING TO PUBLIC SERVICE.

LAB, FIN

Requires every state agency to report to the legislature all non-civil service, temporary employees employed by the agency for each quarterly period of the fiscal year. Establishes a definition for initial probation period; amends section 27(a)(1), HRS, to provide that the initial probation period for a person transferring between a position exempt under section 76-16, HRS, to a civil service position between 12/15/2009 and 12/31/2011 shall be 12 months. (SD1)

## SB2662, SD2 RELATING TO PORNOGRAPHY OFFENSES AGAINST CHILDREN.

JUD

Amends the offense of promoting pornography to minors to include disseminating pornographic material to another person who represents that person to be a minor; and adds the offense of promoting child abuse in the third degree to the information charging law. (SD2)

## SB2669, SD2 RELATING TO THE SOLICITATION OF FUNDS FROM THE PUBLIC.

Amends chapter 467B, Hawaii Revised Statutes, to allow service of process by substitute service, allows the Attorney General to accept assurances of discontinuance, and amends and clarifies the charity registration exemptions, and clarifies the time period for the filing of a charity's annual financial report. ## SB2709, SD1 RELATING TO ENVIRONMENTALLY SENSITIVE PRODUCTS.

Adds the design for the environment program of the United States Environmental Protection Agency and the EcoLogo program administered by TerraChoice Environmental Marketing Inc. as additional programs whose approved cleaning and maintenance products will be given first preference by the DOE in the purchase and use of cleaning and maintenance products in public schools. (SD1)
