SB2570, SD1, HD1

PROPOSING AN AMENDMENT TO ARTICLE X, SECTION 2, OF THE HAWAII CONSTITUTION, TO CHANGE THE BOARD OF EDUCATION FROM AN ELECTED BOARD TO AN APPOINTED BOARD.

Amends the Hawaii Constitution to provide for a Board of Education whose members are to be appointed by the Governor, as provided by law, and to remove the nonvoting student member. Effective July 1, 2020. (SB2570 HD1)

SB2571, SD2, HD1

RELATING TO THE BOARD OF EDUCATION.

Requires the members of the Board of Education to be nominated and, by and with the advice and consent of the Senate, appointed by the Governor from lists of qualified candidates presented to the Governor by the Board of Education Selection Advisory Council. Effective July 1, 2020. (SB2571 HD1)

SB2617, SD1

RELATING TO PUBLIC AGENCY MEETINGS.

JUD

Amends the notice requirement of public agency meetings to allow for notification of meetings and transmittal of meeting minutes by electronic mail. Requires concurrence from office of information practices rather than the attorney general for board to hold emergency meeting for unanticipated events. Requires executive meetings of boards to be properly noticed, and requires subject matter and discussion in an executive meeting
