In support of HB 1190-Relating to Traffic Accidents Investigations

Aloha Chair English, Vice Chair Gabbard and members of the Transportation, International, and Intergovernmental Affairs

I am LTC Soo Ling Lo, of the US Army Reserves. I am here to testify in favor of HB 1190. Over a year ago there was a pedestrian traffic fatality on Ft. Weaver Road. The body was determined dead at 0600 hours, but the body was not picked up until 1100 hours. Meantime, the road was closed to traffic for 5 hours. This is the reason that we need to amend our laws. What happens is once the paramedic has made a determination that the person has ~~die~~d, they are no longer responsible and will not have anything to do with the body. The body is now under the jurisdiction of the medical examiner. Under the current law, the police only call for the medical examiner after their investigation has been completed. The police investigation could take hours. Meanwhile the motorists are impacted, as they are held at a standstill while the body lies on the pavement covered by a white sheet.

This bill simply asks that the medical examiner be called to the scene once a fatality has been confirmed. Depending on the time of the day or day of the week, the response time of the medical examiner could also be hours. By notifying the medical examiner right away and allowing the medical examiner to conduct his/her investigation with the police also conduct their investigation would definitely expedite freeway or highway clearance. Our roadway system is very limited, every little improvement helps.

I respectfully ask for the passage of this bill. Thank you for allowing me to testify.
