Thank you for this opportunity to testify in support of HB 2383.



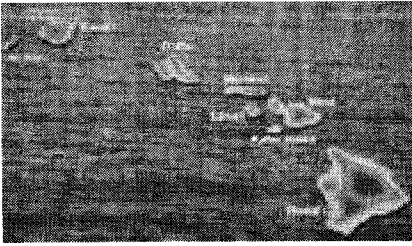

As the son of a 442nd Regimental Combat Team Veteran and the uncle of a Captain in the U.S. Air Force, I proudly testify in support of H.B. 2383, which requires that the National League of Families' Prisoner of War/Missing in Action flag ("POW/MIA flag") be flown with the United States and Hawaiian flags at most State buildings to honor American prisoners of war and military personnel who are missing in action.

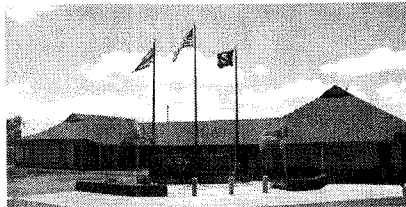
