Aloha. Please accept this testimony in opposition to HCR220 and HR149

A great deal of work has been done these last 6 years in this community, with far reaching effects, related to domestic violence. Regular meetings were held, debates took place, research was compiled and inquiries from experts were made. Many recommendations and several pieces of legislation have emerged from the discussions and efforts of the working group.

The Domestic Violence Action Center recognizes that ongoing dialogue can be advantageous, but certain of the issues raised and considered can have damaging consequences for victims facing life threatening violence. Continuing the group work could result in recommendations and legislation that are not in the best interests of victims of domestic violence. Cases that involve domestic violence face unique challenges in the family court system, and the working group may not be able to address these specific concerns.

Additionally, we do not want the working group to undermine the progress that has been made by the Hawaii Legislature and nationally by the Violence Against Women Act (VAWA) in protecting the rights of battered women and their children in family court.
