Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to testify on House Concurrent Resolution No. 183/House Resolution No. 118. We are providing comments on these resolutions to explore ways to meet the needs and opportunities of Hawaii's agricultural industry in the twenty-first century.

This is a very large undertaking and if a comprehensive review and evaluation is to be accomplished to come up with meaningful recommendations, it will take a significant time commitment for all involved as no resources are allocated and staff is already stretched thin. We question whether this is the time to initiate this task.

We would like to recommend that consideration be given to include a representative of the counties as they are mentioned in the resolutions as well as a representative from the Hawaii State Energy Office of the Department of Business, Economic Development and Tourism in order that bio-fuel production be included in the discussion.

My company employs over 150 people, selling primarily agricultural products from Hawaii. The organic segment is the fastest growing part of the agriculture industry. Too often our concerns have been ignored.

We realize any discussion about sustainability and food sovereignty can only achieve meaningful outcomes if the voices and ongoing work of people and organizations now creating positive change ~ through farmers markets, csa's, school gardens, neighborhood groups, conservation and green tech applications , watershed stewardship and restoration and other solutions ~ are included.

A working group such as this, convened at the taxpayers expense, could only conduct meaningful discussions if larger considerations are brought forward through perspectives of organizations such as Hawaii Farmers Union and the Hawaii Organic Farmers Association.

With regards to the composition of the Agricultural Working Group proposed in this resolution:

The members of the working group need to be far more diverse, and primarily representative of local, small scale, regenerative and diversified agriculture.

As listed, most of the representatives are from large-scale, relatively non-diversified and entirely non-regenerative agricultural sectors or from sectors of industry and academia that support same.

These persons and organizations simply do not have the practices, skills or information necessary to increase local food security and self-sufficiency. They ought to be present in the working group in order to learn, however they do not belong in the driver's seat.

I urge you to explicitly include representatives from organizations such as all local farmers' markets, Hawaiian cultural practitioners focused on agriculture, the Hawai'i Farmers Union, and other truly local voices for our agricultural future.

Dear Representative Tsuji and Members of the Committee:

I am sending this testimony to express my **strong support for HR118/HCR183**, “Requesting the Legislative Reference Bureau to Convene an Agricultural Working Group to Recommend Structural Changes to Meet the Needs and Opportunities of Hawaii’s Agricultural Industry in the Twenty-First Century.” Hawaii currently imports almost all of its food supply, causing a \$3.7 billion drain on Hawaii’s economy and placing the State at risk of food shortages if there is ever an interruption in ocean transport. Hawaii could produce far more food than it presently does, but the expansion of agriculture and aquaculture are constrained by economic, social, and regulatory factors.

Under Hawaii’s Constitution, it is the responsibility of State government to encourage the expansion of diversified agriculture and promote agricultural self-sufficiency. I do not believe that the State can fulfill this responsibility without major changes in policy regarding land use, water development, environmental and health regulation, and transportation. We need a comprehensive plan to address these policies, and a multigenerational commitment to carry out the plan. The agricultural working group that would be established by HR118/HCR183 is a first step towards creating such a plan.

I would like to suggest one small amendment to these resolutions, however. As an individual who has been involved in Hawaii’s growing commercial aquaculture industry for the last 30 years, I would like to see a person with authority in this industry – perhaps the President of the Hawaii Aquaculture and Aquaponics Association, the Director of the State’s Aquaculture Development Program, or the Director of the University of Hawaii’s Sea Grant program -- be included in the list of working group members.

Thank you for the opportunity to testify on this important measure.
