Chair Oshiro and Committee Members:

I am Major General Bob Lee, Director of Civil Defense, State Department of Defense. I am providing written testimony in support of Senate Bill 2054 SD2.

Senate Bill 2054 SD2 establishes within the State Civil Defense Agency a Statewide Communications Interoperability Coordinator (SWIC). Creating this SWIC function recognizes the importance and complexity of multi-jurisdictional collaboration and partnerships among our many public safety agencies to achieve effective voice and data communications during routine and emergency situations.

To be eligible for future federal funding and technical assistance in support of communications programs, the National Emergency Communications Plan that was adopted by Congress states that all states and territories should establish full-time statewide interoperability coordinators or equivalent positions. The SWIC position will be 100 percent federally-funded under the FY 2009 Interoperable Emergency Communications Grant to State Civil Defense.

Thank you for the opportunity to provide written testimony on behalf of an important emergency preparedness initiative. Your support for Senate Bill 2054 SD2 will help build a strong public safety communications program in Hawaii. We urge the Committee to pass this measure.
