The City and County of Honolulu's Elderly Affairs Division (EAD) is strongly in support of S.B. 819 Relating to Kupuna Care with a revision to the appropriation amount and the need to add this amount to the base budget. EAD is Honolulu's designated Area Agency on Aging and operates in accordance with the Older Americans Act of 1965 to coordinate, advocate, and improve services to assist older persons in leading independent, meaningful, and dignified lives in their own homes and communities for as long as possible.

This bill affords additional funding for the Kupuna Care program which provides for essential services that support the needs of the increasing population of frail elderly residents in Hawaii. The funding included in this bill is essential to maintaining the health and welfare of our most vulnerable seniors. We are also in agreement with SSCR 2243 that the appropriation amount contained in S.B. 819 should be \$2,963,411. STATEMENT OF THE ILWU LOCAL 142 ON S.B. 819, SD1 RELATING TO KUPUNA CARE

The ILWU Local 142 supports S.B. 819, SD1, which appropriate funds for the Kupuna Care program.

Kupuna Care is a highly recognized program to support the elderly who live independently in their own homes. Due to the State's budget shortfall, the program has suffered deep cuts in funding at a time when services actually should be expanded to meet the needs of a rapidly growing elderly population. Kupuna Care services like adult day care, chore services, home-delivered meals, attendant care, homemaker services, personal care, and transportation help to prevent institutionalization, which comes with huge costs that will, ironically, require even more taxpayer support.

While we fully understand the State's continuing budget crisis, we believe appropriation of funds for Kupuna Care will be an investment in keeping the elderly at home and will, in the long run, save the State the dollars required to match Medicaid funds for long-term care. Kupuna Care, like other safety net services, is vital to allowing the elderly to remain independent and in the community.

My name is Barbara Kim Stanton, State Director of AARP Hawaii. AARP is a membership organization of people 50 and older with 150,000 members in Hawaii. We are committed to championing access to affordable, quality health care for all generations, providing the tools needed to save for retirement, and serving as a reliable information source on issues critical to Americans age 50+.

AARP strongly supports SB 819, SD1. Its purpose is to appropriate funds to the Kupuna Care program which would add to its base budget under the Executive Office on Aging. The base budget has remained flat at \$4,854,350 since 2002, and has not kept pace with the need for services, resulting in cuts to core services for clients. Budget limitations have led to more stringent rules being applied where clients receive less services than their needs require. In addition to the clients currently served, there is a vast underserved population for whom budgetary resources are simply unavailable.

Kupuna Care is a program that reduces the number of older adults from going into poverty due to the high cost of long-term care. Individuals served fall within the "gap group" – people who cannot afford to pay for services but do not qualify for Medicaid.

Kupuna Care renders substantial cost savings to the state through the basic services it provides to the homebound elderly, such as meals, baths and personal care. This assistance supplements the care provided by family caregivers and gives them needed respite. The state could not financially afford to replace the estimated 169,000 family caregivers in Hawaii. As the aging population needing care has grown, Kupuna Care services have been reduced. Clients face few alternative long term care options. They cannot afford the \$123,000 annually for nursing home care, and are likely to become Medicaid eligible where the state would have to pick up the \$75,000 annual cost.

The fact that Hawaii has one of the nation's fastest growing elderly populations points to an immediate need to support home and community based services such as Kupuna Care. The value of the services that Hawaii family caregivers provide to their loved ones by way of deferred paid caregiving and institutionalization is conservatively estimated at \$1.45 billion, which helps to control state and federal costs. Catholic Charities Hawaii (CCH), is a tax exempt, non-profit agency that has been providing supportive home and community based services to elders since 1973 and currently serves approximately 5,000 older persons each year. We support SB 819, SD1, to increase Kupuna Care funding for senior services and ask that additional funding in the amount of \$2,963,411 be included for FY 2010-2011.

Catholic Charities Hawaii has provided Kupuna Care Transportation Services for a number of years. In addition, we have been partners with other aging network providers who also provide essential State-funded Kupuna Care Services such as home-delivered meals, case management, chore & housekeeping, bathing service and more.

State-funded Kupuna Care currently funds a set of basic, essential services that help frail elders remain independent and avoid institutionalization or homelessness. In addition, these services support family caregivers who are providing support to frail elderly relatives who still want to maintain their independence but require supportive services, from family and the community, in order to do so.

Aging network providers cannot meet the growing demand for services when faced by years of flat or reduced State and Federal funding and the growing cost of service delivery due to aging vehicles, increased cost of gas and utilities, increased cost of providing health insurance for employees, etc.

At a cost of approximately \$7,000 a month per person, institutionalization of elders is a burden on taxpayers and government. Additional funding for community-based Kupuna Care services will allow our kupuna to remain in the community (which they prefer) and avoid costly institutionalization.

- 2) Add wording from SB2260: That this additional amount be added to EOA base budget.


The mission of Child and Family Service is strengthening families and fostering the healthy development of children. We do this by providing services from our youngestKeiki to our oldest Kupuna. Hawaii's strength comes from its 'Ohana which includes our elders. We believe that supporting our seniors will also help us to stabilize our economy by preventing premature institutionalization which in turn will increase the state dollars needed to pay for long-term care for our Kupuna.

The Kupuna Care Program is directed at serving those who fall through the gaps in services. It provides a safety net to prevent institutionalization and support seniors in their homes. The waitlist for these services continues to grow as the senior population grows and more seniors face difficult economic times. They are often times choosing to pay for food or medication, doctor visits or rent.

Evidenced-based studies have reported that early intervention is the key to better outcomes for seniors requiring supportive services to remain in their community. A 2002 study reported in The Gerontologist, "Effects of a Community-Based Early Intervention Program on the Subjective Well-Being, Institutionalization, and Mortality of Low-Income Elders", "those elders who received the intervention (case management) had significantly higher subjective well-being and were less likely to be institutionalized or die than those in a comparison group (remained on wating lists for case management) across the 18-month period." The study states that the implications of the results are that they "make a strong case for the importance of community-based programs to the well-being of elders".

We also urge the Legislature to be creative this session in making appropriations. There is strong competition for limited state funds due to the economic recession. While the appropriation provided for in this bill is necessary, it is not sufficient to ensure that the Legislature's intent will be fulfilled.

When Governor Lingle withheld more than \$500,000 that was to go to Kupuna Care in 2006, reports circulated of seniors leaving the hospital who had to be readmitted because they could not get services needed to stay at home.

Several organizations had written letters asking that the money be released to no effect. Finally, the Friday before Election Day a flock of press releases resulted in the release of the funds.

That money was withheld before the current recession. Now that funds are limited, we are afraid that senior services will be among the first to be cut instead of the last.

Anything that this Committee or the Legislature is able to do to effectuate the Legislature's intent in structuring the state's budget would be of great benefit to seniors and others who depend on these programs.

The National Multiple Sclerosis Society supports SB 819, SD1 which appropriates additional funds for the Kupuna Care program.

The MS Society is dedicated to helping people living with MS and their families, the elderly, and others with chronic disabling diseases secure the critical services they need. The Society supports expansion of public and private long-term care options, especially those that keep individuals in the community and functioning at the highest possible level.

For a couple in their late seventies who live in a rural community, finding someone to provide personal care for the spouse with progressive multiple sclerosis was a huge challenge—until they were able to access case management services through the Kupuna Care program. Both partners had physical limitations so it was extremely difficult for the spouse to transport his wife in and out the bed, the shower, or the commode. With the help of personal care attendants, and homemakers to help with housework, the man was able to get several hours of respite during the week, take the car to the shop, and tend to other business around the home. Although the services were not unlimited, they helped this couple get through one of the most difficult periods of their lives. Those services and many others provided through Kupuna Care are being threatened with little or no options available to the recipients and their family members.

Nearly a quarter of individuals living with multiple sclerosis will require long-term care services and supports at some point during the course of the disease. Individuals with MS who have more significant disabilities require long-term and significant amounts of assistance with virtually all ordinary activities. A recent study on informal caregiving to people with MS found that both caregivers and persons with MS were close to sixty years old, significantly older than the MS population; and eighty percent of such care is provided by informal caregivers, usually family members.

We support SB 819, SD1 and ask you to vote in favor of this Bill. Thank you for the opportunity to testify.

- \$ We understand the current fiscal crisis facing the state of Hawaii. However, frail elders are in immediate need of care and meeting their needs for care should be an important priority for public support.
- The Kupuna Care serves persons not eligible for Medicaid services, enables families to care for their elders at home, and also keeps persons from having to go on Medicaid. Not to fund basic home and community services would result in many persons having to use higher cost residential care, usually at public expense.
- The current Kupuna Care services fall short of meeting the critical need, and the demand for these services will continue to grow. As of September 30, 2009, there were 594 older adults waitlisted for services. As of June 30, 2009, the estimated wait-time to receive home delivered meals was over 4 months. The state is falling far short of providing for its most vulnerable citizens who are in critical need.
- These critical services have major impacts on the quality of life of frail elders and their caregivers and the cost of the services is relatively low compared to other expenditures of the state. Thus, we strongly recommend support for additional funding in order to meet our moral obligations to those in greatest need.

They prepared his meals, cleaned his house and provided daily hygenic care for him. Although they did an ok job, their motivation seemed to be focused on extracting money from his wallet. Over time some things went missing. Also over time my neighbor mentioned how he was running out of money, which in his mind ment the end.

By the end of the week my neighbor was found dead, assumed suicide. The circumstances were suspicious, with his personl safe wide open and all its contents missing. Whether it was his own decision or that of some of his caregivers, it appeared that he felt he had no choices.

If he were aware of Kupuna care, his last days may have been more enriched. He may even be alive today. Kupuna care saves lives. This vital service is necessary for the people in our community who need assistance with their daily living needs, like transportation, meals and in home care. My name is Steve Tam and I am a resident of Hawaii Kai and a caregiver for both my father in Aina Haina, and father-in-law in Maunawili. I am testifying in support of SB 819 SD1 relating to Kupuna Care.

The State is faced with a "ticking time bomb," as in 20 years, 1 in 4 people will be over 60 years old, and faced with unfathomable long term care costs. Nursing home costs are now in excess of \$120,000 annually. Most families cannot afford such an expense, and instead rely upon a combination of utilizing unpaid family caregivers, and draining life savings to pay for in-home care. It's ironic in that spending life savings will qualify seniors for Medicaid, which would in turn be more expensive and a larger cash drain for the State and all taxpayers.

I urge that you appropriate funds for Kupuna Care. This Home and Community Based Service allows seniors to remain in their home as long as possible, and gives caregivers respite by helping their loved ones with baths, hot meals, toileting assistance, transportation, and other household chores. These seniors are part of the unlucky "gap" group that does not have enough monies to pay for all the assistance to meet daily needs, yet have enough money and thus cannot qualify for Medicaid. This gap group is the beneficiary of Kupuna Care.

Caregivers also benefit from Kupuna Care. A staggering 1 in 4 adults in Hawaii (approximately 169,000 people), provide caregiver services worth about \$1.4 billion annually. Caregivers provide these services at no cost to the State. However, caregivers cannot do it alone, and would "burn out" without occasional help to care for parents, and allowing time to take care of themselves and their children. Cutting the Kupuna Care Program would not result in a cost savings, but instead result in a cost increase to the State, as caregiver "burn out" would mean that the State would be burdened with the entire senior long term care costs, rather than the smaller Kupuna Care costs for occasional caregiver respite and senior assistance.

As a caregiver for my father who has Alzheimer's, and my father-in-law who had a stroke, this is of great personal interest to me. I left my full-time job in part to care for my parents and in-laws. However, I need to return to work to pay for my children's college education. I have found that there are many families in similar situations. If all these caregivers were unable to give of their own time, the State would be faced with a severe social service catastrophe.

In summary, funding for Kupuna Care is essential to the senior population and their caregivers, and cannot be put off to a later date, as to do so, will severely lessen the quality of life of our seniors, and ultimately place extreme financial burdens on the State, when forced to deal with the issue.
