Aloha, I am Maunalei Love, executive director of the Charter School Administrative Office ("CSAO"). I want to thank the chair and the entire committee for the time and effort being spent to remedy the issue of adequately providing needed resources to charter school and all public schools students to give them the educational opportunities that will enable them to succeed.

The ongoing work of interested public education stakeholders is increasing the transparency and understanding of educational funding. These efforts must continue. As such, we support the intent of this measure to expand upon that work.

We recommend that the following sentence be added to recognize the accomplishments of that group:
