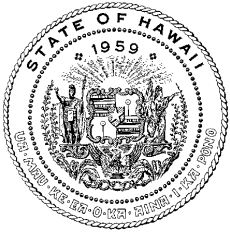

On behalf of Local 665, International Alliance of Theatrical and Stage Employees (IATSE), with over 500 members and 300 referrals and growing, we support SR 55 and SCR 139.

The intent of convening a joint legislative work group to develop recommendations for incentives to assist film and creative media and defense and dual-use industries is a positive step to looking ahead on we can grow these industries in Hawaii.

Chair Fukunaga, Vice Chair Baker, and members of the committee.

My name is Charles Ota and I am the Vice President for Military Affairs at The Chamber of Commerce of Hawaii (The Chamber). I am here to state The Chamber's support of Senate Concurrent Resolution 139 and Senate Resolution 55, both relating to convening a joint legislative work group to develop recommendations for incentives to assist film and creative media and defense and dual-use industries.

The resolutions propose to convene a joint legislative group to develop recommendations for incentives to assist film and creative media and defense and dual use industries.

The Chamber has two groups that serve to provide oversight for the defense industry. They are the Military Affairs Council (MAC) and the Defense and Dual Use Technology Committee (DDUTC).

The MAC and DDUTC fully support the proposal to continue the work of the technology caucus work group in seeking incentives to assist the film and creative media and defense and dual-use industries.

The DDUTC includes representatives from prime US defense contractors such as BAE Systems, Northrop Grumman, SAIC, Lockheed Martin, Boeing, Booz Allen Hamilton, and Raytheon, and a large number of Hawaii's R&D companies led

by Oceanit, Referentia, Puko`a Scientific, Tera Systems Technologies, Concentris Systems, Sopogy, and Novasol.

The Chamber requests that DDUTC members be included as participants on the working group.

We respectfully request that the proposed measure be approved for adoption.
