The Department of Public Safety (PSD) thanks the legislature for their interest in having the Corrections Population Management Commission (CPMC) resume meetings and the meetings to be conducted quarterly.

It should be noted that the CPMC has been meeting quarterly from June 2008. The most recent meeting scheduled for March 11, 2010 was unfortunately canceled due to CPMC members' legislative duties that prevented a quorum from being reached. PSD will continue to support the efforts of the CPMC. However, without adequate paid staff positions solely dedicated to the CPMC, the commission will not be able to fully fulfill its mission as outlined in HRS §353F.

Aloha Chair Espero, Vice Chair Bunda and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a diverse community initiative working to improve conditions of confinement for Hawai'i's incarcerated individuals, enhance the quality of justice, and promote public safety by supporting smart justice policies. We come today to speak for the 6,000+ individuals whose voices have been silenced by incarceration, always mindful that almost 2,000 of those individuals are serving their sentences abroad, thousands of miles from their homes and loved ones.

SCR 190/SR 89 requests the Corrections Population Management Commission to resume its meetings and to meet at least quarterly.

Community Alliance on Prisons supports this measure.

The Corrections Population Management Commission (CPMC) was formed when the Department of Justice imposed a Consent Decree on Hawai'i for severe prison overcrowding. The CPMC is a legislatively appointed body that was established through Act 343, Session Laws of Hawaii 1993. It expanded from eight to eleven members representing all three branches of state government, the county prosecuting attorney, and two community representatives. The objective for the CPMC is "establish maximum inmate population limits for each correctional facility and to formulate policies and procedures to prevent the inmate population from exceeding the capacity of each correctional facility" (Section 353F-4, Hawaii Revised Statutes). The CPMC is administratively attached to the Department of Public Safety.

The CPMC is currently meeting quarterly, but this just started in June 2008. This legislatively appointed body should have been part of the discussion on the proposed closure of Kulani. If they had been meeting and given the population numbers at each facility, they would have been aware that the population at Kulani was decreasing.

Had the population numbers been distributed, the CPMC could have questioned why PSD was decreasing the population of Kulani - the facility with the largest and most successful sex offender treatment program in the nation - while the administration was introducing plenty of bills regarding sex assault, which would inevitably increase the incarceration of sex offenders.

This lack of transparency is very disappointing from an administration that promised in A New Beginning for Hawai'i:

*Making Government Work Better*

*"Restoring integrity to government requires us to share information openly with the public so the people of Hawai'i will know the true condition of state government, the programs it operates and the results of its efforts. Both elected leaders and the public must know the information essential to good decision-making. Government resources are limited, so all spending and policy choices must be based on reliable information and clearly articulated values and objectives, rather than short-term political considerations. ...Financial accountability and openness are essential if government leaders are able to make sound decision and then be held accountable for the actual results. They are absolutely necessary to break the vicious cycle of corruption and favoritism in state contracting, and to restore trust and integrity in government service."*

The CPMC was established to control the incarcerated population and determine how to best handle increases. The fact that 54% of Hawai'i's prison population is abroad should be a matter of great discussion for the CPMC. We were heartened to hear PSD tell the House Public Safety Committee that from now on they would be distributing population reports at the CPMC meetings, which are open to the public.

The Corrections Population Management Commission provides a level of oversight of the Department of Public Safety, which is sorely needed.

Committee members, even though the Lingle administration is on their way out, please make them do their jobs and hold them accountable, as they demand from those in their custody.
