Chair Espero, Chair English and Committee Members:

I am Major General Bob Lee, Adjutant General, State Department of Defense. We strongly support Senate Concurrent Resolution 207.

Since September 11, 2001, at the call of the President, the Hawaii National Guard and Reserves have activated and deployed soldiers and airmen in support of America's war on terrorism. Within the last six years, the Hawaii Army National Guard, along with the Army Reserves has deployed units in support of Iraqi and Enduring Freedoms. In fact, our 29<sup>th</sup> Infantry Combat Team, which includes the 100<sup>th</sup> Battalion, 442<sup>nd</sup> Infantry from the Army Reserves, have deployed twice to Iraq in support of Operation Iraqi Freedom within the last six years.

We are continuing to train, mobilize, and deploy our units in support of our nation's war. Currently we have two National Guard units scheduled to deploy to Afghanistan in support of Operation Enduring Freedom.

These overseas combat tours have disrupted the lives and employment of our citizen soldiers and airmen. Some have lost employment and others have been overlooked for promotions. Passage of the National Guardsmen and Reservists Parity for Patriots (H.R. 208) and the National Guard and Reserve Retired Pay Equity Act of 2009 (S. 644) would truly indicate of our citizen soldiers, airmen, and reservists that America cares and support their service to our country.
