In consideration of SENATE CONCURRENT RESOLUTION 87/SENATE RESOLUTION 38 URGING THE HAWAII PUBLIC HOUSING AUTHORITY TO ESTABLISH HOMELESS SAFE ZONES

Senate Concurrent Resolution 87/Senate Resolution 38 requests that the Department of Land and Natural Resources (Department) lease or contract with the Hawaii Public Housing Authority (HPHA) any available public lands for the purpose of establishing homeless safe zones. The resolution also requests that the Department provide assistance to HPHA and any provider agencies contracting with HPHA, in identifying, contracting, and conveying land and improvements available for use by provider agencies as homeless safe zones. Given the State's current fiscal situation, the Department opposes this measure.

The Department's general fund has been cut 32% over the past 3 years, special fund revenues have declined 35% over the past 3 years, and the Department has lost 80 positions in the recent Reduction-in-Force this past year. Any further cuts or additions of new unfunded mandates will likely result in loss of staff and maintenance and operations of core departmental.

Moreover, the Department's workload continues unabated while its available workdays have been reduced by two days a month due to furloughs. Any additional demands and responsibilities imposed upon the Department's over burdened staff will further diminish the Department's ability to carry out its core functions and seriously debilitate its ability to generate sufficient revenues to meet its minimum budgetary requirements to operate effectively.
