S.C.R. 93 REQUESTING THE HAWAII HOUSING FINANCE AND DEVELOPMENT CORPORATION TO REVIEW THE FEASIBILITY OF DEVELOPING SINGLE ROOM OCCUPANCY DWELLINGS IN TRANSIT ORIENTED DEVELOPMENT PROJECTS, TO ALLEVIATE THE AFFORDABLE HOUSING SHORTAGE.

The HHFDC **opposes** S.C.R. 93 because it is not able to undertake the review due to budgetary constraints, the hiring freeze, and the considerable amount of compliance and reporting obligations the HHFDC now has incurred since its receipt of federal stimulus funds.

HHFDC believes that Single Room Occupancy dwellings can be an important part of the solution to the lack of affordable housing. However, we note that in 2009, the City and County of Honolulu Department of Planning and Permitting testified that it was already actively preparing for Transit Oriented Development (TOD) with the development of neighborhood TOD plans, and subsequent zoning and financial mechanisms to guide private sector projects toward meeting adopted community values and opportunities, and that affordable housing is one of the topics being studied.

Subject: Senate Concurrent Resolution No. 93 Relating to Single Room Occupancy Dwellings in TOD Projects

The Department of Planning and Permitting **supports** Senate Concurrent Resolution No. 93 which requests the Hawaii Housing Finance and Development Corporation (HHFDC) to review the feasibility of developing single room occupancy dwellings (SROs) in transit-oriented development (TOD) projects.

The City's ongoing neighborhood TOD planning efforts have clearly identified the need for affordable housing opportunities in communities near transit stations. Households near transit stations have greater access to jobs, services, and recreation, without the need to own a private automobile. They have lower total transportation costs and contribute to higher transit ridership. SRO is part of the TOD housing mix that will need to be explored for Honolulu.

HHFDC can promote and enable affordable housing projects, like SROs, through partnerships with private and public entities. Ultimately, SROs will need to take into account the special development rules that will be in place around transit stations.
