I would like to express my unequivocal support for SCR 202 and SR 101, Google Inc. to Select Hawaii as a Test Site to Conduct the Google Gigabit Broadband Initiative. The City and County of Honolulu has positively responded to Google's Request for Information (RFI) for a new high-speed broadband network. Honolulu is uniquely capable of utilizing the advanced features of fiber-to-the-home connectivity for telecommuting and home business applications.

Our "Second City" of Kapolei may be an ideal community for Google's initial pilot project. It is a master planned community of consistently modern construction and infrastructure, with extensive underground conduit access already in place and well as existing international fiber connectivity. Kapolei has both a business and residential district with relatively upscale income demographics and high household educational levels. It is also adjacent to the resort area of Ko'olina, the site of the future Disney resort.

Honolulu is presenting its response to the Google RFI in conjunction with the State of Hawaii and our sister counties. We present a united team ready to assist Google in the deployment of this new fiber network in any location in our state and in any scale that they might wish to undertake.

My name is Ron Boyer, Acting Director of the Department of Commerce and Consumer Affairs ("Department"). The Department appreciates the opportunity to provide written comments in support of these resolutions.

Google's "Fiber for Communities" experiment proposes to bring 1-gigabit-per-second internet speed to one or more U.S. locations on a trial basis. Senate Concurrent Resolution 202 and Senate Resolution 101 urge Google to select Hawai'i as a test site for conducting its gigabit broadband initiative.

The Department concurs that Hawai'i would make an optimal location for Google to demonstrate the revolutionary benefits of high speed broadband, given the strong

community interest, government support, ideal weather conditions, varied topography, near universal penetration of cable television, and the higher than average subscription rates for broadband usage.
