In consideration of SENATE CONCURRENT RESOLUTION 77/SENATE RESOLUTION 33 REOUESTING THE AUDITOR TO CONDUCT A FOLLOW-UP AUDIT OF THE MANAGEMENT OF STATE BOATING FACILITIES BY THE DIVISION OF BOATING AND OCEAN RECREATION OF THE DEPARTMENT OF LAND AND NATURAL RESOURCES

Senate Concurrent Resolution (SCR) 77/Senate Resolution (SR) 33 authorize the Legislative Auditor to conduct a follow-up audit of the Division of Boating and Ocean Recreation (DOBOR) of the Department of Land and Natural Resources (Department). The Department does not believe that an audit is necessary as DOBOR was already the subject of a legislative financial audit in 2006 and management audits in 2001, 1998, and 1995.

DOBOR has proceeded to implement strategies of the Department's Recreational Renaissance Plan to improve its facilities, including the recent amendment to the mooring fees and offering of fast lands for long term leases. The Department notes that boaters and the Board of Land and Natural Resources have asked DOBOR to develop an accounting to segregate the new revenues developed under the Recreational Renaissance Plan so that they can document amounts received and the specific expenditures. The Department recommends the Legislature amend these resolutions to direct DOBOR to do the same, and to report that accounting system back to the Legislature next year. In the event the report is unsatisfactory, the Legislature could then move forward with a management audit at that time. The Department is concerned that an audit at this juncture will take valuable time away from DOBOR's limited staff, already decimated by furloughs.

DOBOR has worked diligently to utilize legislative funding to improve the conditions of its facilities and has implemented many of the recommendations from those audits and substantial improvements have been made to the internal processes. DOBOR, with the help of the Legislature, is addressing the over \$300 million in deferred Capitol Improvement Program (CIP) projects at its harbors and ramps, and has utilized over \$70 million in CIP funding over the last eight years.

Testimony in Support of SR 33

My comments are directed towards DOBOR's blue card program. The permits issued to surf schools by DOBOR are being improperly issued in my view. For what ever reasons the so called blue card permits do not come with clear conditions, nor has DOBOR been vigilant in monitoring permit holders for compliance. It is my belief that DOBOR staff is unwilling to hear or act on tips relating to violations by Blue Card holders (permittees). The Courts moreover are confused by cases brought to them by DOBOR, resulting in no fines and a problematic situation with regard to abuse.

I feel that DLNR should be required to re-vamp the blue card program along the lines of the city and county's program, who's permit process is very efficient and without the sort of confusion that plagues the DOBOR program. The problem in a nut shell is that the blue card permits are issued without clear performance conditions and or rules. The so called grey areas in the rules are responsible for the loop holes because they are easy to violate and operators are never held accountable. There are numerous individuals including myself who have documented DOBOR's failure to act on complaints. I have been trying for several years to get boating Administrators and enforcement officers at DOCARE to not only investigate problems we report on but to properly outfit surf schools with rules they can enforce. I'm aware of many incidents that should have warranted investigations and or permit revocations. I'm referring now to surf schools who are in the habit of knowingly breaking the law (abusing their permits). Typically when we have attempted to bring these sorts of violations to their attention, DOBOR's reaction is always the same, "don't call us call DOCARE"! If we tell them DOCARE won't respond, they will simply say that they are unable to investigate blue card violations because of "staff shortages." Without staff to adequately monitor or enforce violations committed by those they issue permits to, the public has no reassurance that our natural resources are being protected. Moreover this is forcing some to encounter the violators themselves, often resulting in threats from surf school owners. The Boating division should therefore be forced to discontinue the program until it can craft clear rules which spell out clear permit conditions! (I have ides on how DOBOR should approach this subject if anyone wants to hear them).

In addition to the blue card problem there are at least 7 hotels along the Waikiki shoreline who are using the public portion of the beach for personal enrichment in violation of state law regarding commercialism on public beaches, specifically, the 1928 Beach Agreement that prohibits the hotels

from engaging in commercial activity on Waikiki beach. DLNR must require the hotels to apply for commercial permits since they are using up beach space with commercial equipment way beyond their property lines in violation of the law. I challenge Senators to disprove me on the Waikiki beach commercial restriction. Anyone in state government feel I'm wrong on this? Please state your position and I will offer my response to you in writing. My contention is that DOBOR does not understand even the most basic rules governing permits, procurement, public vetting etc. The Land Board should no longer be allowed to rubber stamp DOBOR when they do things totally backwards as in issuing commercial permits before they do rules, before public hearings, and before they consult the HRS, i.e., their governing charters.


