

# A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. This Act is recommended for immediate passage  
3 in accordance with section 9 of Article VII of the Constitution  
4 of the State of Hawaii.

5 SECTION 2. There are appropriated or authorized from the  
6 sources of funding indicated below to make health care premium  
7 payments (BUF 761) in the following sums, or so much thereof as  
8 may be necessary, to fund for fiscal biennium 2009-2011 the  
9 Hawaii employer-union health benefits trust fund costs contained  
10 in the agreement negotiated with the exclusive bargaining  
11 representative of collective bargaining units 1, 2, 3, 4, 5, 6,  
12 7, 8, 9, 10, and 13:

15 Of the above listed amounts, the following amounts are for  
16 the department of education, including the Hawaii state public  
17 library system:

3 SECTION 3. Funds appropriated or authorized by this part  
4 shall be allotted by the director of finance to the appropriate  
5 state agencies for expenditure in the respective fiscal year for  
6 the purposes of this part.

8 SECTION 4. There are appropriated or authorized from the  
9 sources of funding indicated below to make health care premium  
10 payments (BUF 761) in the following sums, or so much thereof as  
11 may be necessary, to fund for fiscal biennium 2009-2011, the  
12 Hawaii employer-union health benefits trust fund costs  
13 authorized by chapter 89C, Hawaii Revised Statutes, for state  
14 officers and employees excluded from collective bargaining who  
15 belong to the same compensation plans as those officers and  
16 employees within collective bargaining units 1, 2, 3, 4, 5, 6,  
17 7, 8, 9, 10, and 13:


2 General Funds \$257,402

3 SECTION 5. Funds appropriated or authorized by this part  
4 shall be allotted by the director of finance to the appropriate  
5 state agencies for expenditure in the respective fiscal year for  
6 the purposes of this part.

7 SECTION 6. Funds appropriated or authorized by this Act  
8 that are not expended or encumbered by June 30, 2011, shall  
9 lapse as of that date.

10 SECTION 7. This Act shall take effect upon its approval.
