# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated or authorized from the  
3 sources of funding indicated below to the department of budget  
4 and finance, departmental administration and budget division  
5 (BUF 101), the following sums or so much thereof as may be  
6 necessary to fund for fiscal biennium 2011-2013 all collective  
7 bargaining cost items in the agreement negotiated with the  
8 exclusive bargaining representative of collective bargaining  
9 unit (8):

15 SECTION 2. Funds appropriated or authorized by this part

7 adjustments provided in this Act for any officer or employee  
8 whose compensation is paid, in whole or in part, from federal,  
9 special, or other funds shall be paid wholly or proportionately,  
10 as the case may be, from the respective funds.

11 SECTION 14. Funds appropriated or authorized by this Act  
12 that are not expended or encumbered by the end of the fiscal  
13 year for which the appropriation or authorization is made, shall  
14 lapse as of those dates.

15 SECTION 15. This Act shall take effect on July 1, 2011.
