# A BILL FOR AN ACT

RELATING TO FOSTER YOUTH.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Chapter 346, Hawaii Revised Statutes, is  
2 amended by adding a new section to be appropriately designated  
3 and to read as follows:

4 "§346- Housing assistance program for former foster  
5 youth. (a) The department may develop and administer a program  
6 to assist former foster youth in understanding the housing  
7 options available to them and accessing appropriate housing  
8 options as necessary once a former foster youth has attained  
9 eighteen years of age. The housing assistance program shall, at  
10 minimum:

11 (1) Identify former foster youth who have attained  
12 eighteen years of age and maintain a registry for  
13 program use;

14 (2) Notify former foster youth of the program and the  
15 services that can be accessed within the program;

16 (3) Provide former foster youth with information regarding  
17 any available housing options, including public



1           housing, federal and state rental assistance programs,  
2           and federal and state housing programs;

3           (4) Assist former foster youth in obtaining any necessary  
4           documentation required to access any of the programs  
5           referred to in paragraph (3);

6           (5) Assist former foster youth in filling out any forms or  
7           registration necessary to access any available housing  
8           options; and

9           (6) Provide former foster youth with counseling and  
10           guidance regarding housing issues.

11           (b) In developing and implementing the housing assistance  
12           program, the department shall consult and coordinate with other  
13           relevant state agencies, including the Hawaii public housing  
14           authority and the Hawaii housing finance and development  
15           corporation.

16           (c) As used in this section, "former foster youth" shall  
17           have the same meaning as in section 346-16.

18           (d) The department shall adopt rules pursuant to chapter  
19           91, including standards and procedures, to effectuate the  
20           purposes of this section."

21           SECTION 2. There is appropriated out of the general  
22 revenues of the State of Hawaii the sum of \$                    or so much



1 thereof as may be necessary for fiscal year 2011-2012 for the  
2 department of human services to develop and administer a housing  
3 assistance program for former foster youth.

4 The sum appropriated shall be expended by the department of  
5 human services for the purposes of this Act.

6 SECTION 3. New statutory material is underscored.

7 SECTION 4. This Act shall take effect on July 1, 2050.
