## A BILL FOR AN ACT

RELATING TO HEALTHY INITIATIVES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that Hawaii's farmers  
2 face numerous challenges in earning a living off the land. On  
3 average, the farmer's share of every food dollar has dropped  
4 below 19 cents, and in Hawaii, it is even less. Although the  
5 2007 Census of Agriculture for Hawaii indicates that there are  
6 more farms than in 2002, the land in agriculture and average  
7 farm size has decreased, and the average age of farmers in  
8 Hawaii is higher than the national average.

9           The legislature further finds that food safety  
10 certification is a critical component of any healthy initiative  
11 to expand the sale and consumption of Hawaii-grown produce. In  
12 addition to schools, hotels, restaurants, and others in the  
13 tourism industry often seek to buy as much local produce as they  
14 can, and the demand for food safety certification has increased  
15 and is required by visitor industry restaurants. This  
16 requirement has limited the procurement of Hawaii-grown produce.

17           The purpose of this Act is to expand the sale and  
18 consumption of Hawaii-grown produce by establishing a safe food



1 certification pilot program to benefit farmers and consumers  
2 statewide.

3 SECTION 2. (a) There is established in the department of  
4 agriculture a safe food certification pilot program to benefit  
5 farmers and consumers throughout the State.

6 (b) The pilot program shall be managed by the department  
7 of agriculture; provided that the department of health shall  
8 provide the department of agriculture with assistance as  
9 necessary in implementing the pilot program. The pilot program  
10 shall:

- 11 (1) Encourage farmers to form agricultural cooperatives;
- 12 (2) Coordinate purchasing agreements between the  
13 agricultural cooperatives and schools, hotels,  
14 restaurants, and other buyers; and
- 15 (3) Develop and implement "safe" food certification for  
16 products under the pilot program to promote fresh,  
17 high-quality produce grown by Hawaii farmers.

18 All farmers operating in the State shall be eligible to apply  
19 for the pilot program.

20 (c) The department of agriculture shall report to the  
21 legislature no later than twenty days prior to the regular  
22 sessions of 2012 and 2013 on the status of the pilot program and



1 recommendations, including any recommendations for legislation  
2 and funding, to make permanent the safe food certification pilot  
3 program.

4 SECTION 3. There is appropriated out of the tourism  
5 special fund the sum of \$ or so much thereof as may be  
6 necessary for fiscal year 2011-2012 and the same sum or so much  
7 thereof as may be necessary for fiscal year 2012-2013 and such  
8 sum shall be transferred to the department of agriculture to  
9 establish and administer the safe food certification pilot  
10 program established in this Act.

11 SECTION 4. There is appropriated from the  
12 interdepartmental appropriation transferred from the Hawaii  
13 tourism authority the sum of \$ or so much thereof as  
14 may be necessary for fiscal year 2011-2012 and the same sum or  
15 so much thereof as may be necessary for fiscal year 2012-2013  
16 for the department of agriculture to establish and administer  
17 the safe food certification pilot program established in this  
18 Act.

19 The sums appropriated shall be expended by the department  
20 of agriculture for the purposes of this Act.






1 SECTION 5. This Act shall take effect on July 1, 2011;  
2 provided that this Act shall be repealed on June 30, 2013.





**Report Title:**

Farmers; Safe Food Certification; Pilot Project; Appropriation

**Description:**

Establishes a pilot program within the department of agriculture to encourage farmers to form agricultural cooperatives, coordinate purchasing agreements between the agricultural cooperatives and hotels, restaurants, and other buyers in the visitor and hospitality industries, and develop and implement safe food certification for products under the pilot program; requires annual reports to the legislature; appropriates funds.
