A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR SALARY INCREASES FOR PUBLIC EMPLOYEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There is appropriated or authorized from the
3 sources of funding indicated under this section to program
4 planning, analysis, and budgeting (BUF 101) the following sums,
5 or so much thereof as may be necessary, to fund for fiscal
6 biennium 2011-2013 all collective bargaining cost items in the
7 agreements negotiated with the exclusive bargaining
8 representatives of collective bargaining unit (13):

14 SECTION 2. The funds appropriated or authorized by this

There is appropriated or authorized from the sources of funding indicated under this section to program planning, analysis, and budgeting (BUF 101) the following sums, or so much thereof as may be necessary, to fund for fiscal biennium 2011-2013 the salary increases and other cost adjustments authorized by chapter 89C, Hawaii Revised Statutes, for state officers and employees in the executive branch who are excluded from collective bargaining and belong to the same compensation plans as those officers and employees within collective bargaining unit (13):

SECTION 11. There is appropriated or authorized from the sources of funding indicated under this section to hospital care -- Hawaii health systems corporation (HTH 210) the following sums, or so much thereof as may be necessary, to fund for fiscal biennium 2011-2013 the salary increases and other cost adjustments authorized by chapter 89C, Hawaii Revised Statutes, for state officers and employees assigned to the Hawaii health systems corporation who are excluded from collective bargaining:

SECTION 12. The funds appropriated or authorized by this part shall be allotted by the director of finance to the Hawaii health systems corporation for the purposes of this part.

PART VII

SECTION 13. Salary increases and cost adjustments provided in this Act for any officer or employee whose compensation is paid, in whole or in part, from federal, special, or other funds shall be paid wholly or proportionately, as the case may be, from the respective funds.



1 SECTION 14. Funds appropriated or authorized by this Act
2 that are not expended or encumbered by June 30, 2012, and
3 June 30, 2013, of the respective fiscal years, shall lapse as of
4 those dates.

5 SECTION 15. This Act shall take effect on July 1, 2011.
