A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO THE HAWAII CONSTITUTION TO LIMIT THE
ROLE OF THE BOARD OF REGENTS OF THE UNIVERSITY OF HAWAII TO
APPOINTING AND REMOVING THE PRESIDENT OF THE UNIVERSITY,
AND RAISING FUNDS FOR THE UNIVERSITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to propose an
2 amendment to article X, section 6, of the Hawaii constitution,
3 to limit the role of the board of regents of the University of
4 Hawaii to appointing and removing the president of the
5 university, and raising funds for the university.

6 SECTION 2. Article X, section 6, of the Constitution of
7 the State of Hawaii is amended to read as follows:

8 "BOARD OF REGENTS; POWERS

9 **Section 6.** There shall be a board of regents of the
10 University of Hawaii, the members of which shall be nominated
11 and, by and with the advice and consent of the senate, appointed
12 by the governor from pools of qualified candidates presented to
13 the governor by the candidate advisory council for the board of
14 regents of the University of Hawaii, as provided by law. At
15 least part of the membership of the board shall represent
16 geographic subdivisions of the State. The board shall have the



1 power to [~~formulate policy, and to exercise control over the~~
2 ~~university through its]~~ appoint and remove the executive
3 officer[~~7~~] of the university, the president of the university,
4 [~~who shall be appointed by the board. The board shall also have~~
5 ~~exclusive jurisdiction over the internal structure, management,~~
6 ~~and operation of the university. This section shall not limit~~
7 ~~the power of the legislature to enact laws of statewide concern.~~
8 ~~The legislature shall have the exclusive jurisdiction to~~
9 ~~identify laws of statewide concern.]~~ and to raise funds for the
10 university."

11 SECTION 3. The question to be printed on the ballot shall
12 be as follows:

13 "Shall the role of the board of regents of the University of
14 Hawaii be limited to:

15 (1) Appointing and removing the president of the
16 university; and

17 (2) Raising funds for the university?"

18 SECTION 4. Constitutional material to be repealed is
19 bracketed and stricken. New constitutional material is
20 underscored.


