A BILL FOR AN ACT

RELATING TO FUNDING FOR PARKING FOR DISABLED PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 291, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 "§291- Costs. Beginning July 1, 2012, all costs
5 associated with the statewide parking program for persons with
6 disabilities shall be appropriated from the accessible parking
7 special account established under section 348F-A."

8 SECTION 2. Chapter 348F, Hawaii Revised Statutes, is
9 amended by adding a new section to be appropriately designated
10 and to read as follows:

11 "§348F-A Accessible parking special account. (a) The
12 disability and communication access board shall establish and
13 administer an accessible parking special account within the
14 disability and communication access board special fund
15 established under section 348F-7. The accessible parking
16 special account shall accept funds pursuant to section 249-31.
17 All interest earned or accrued on such moneys shall become part
18 of the special account.



1 (b) Moneys in the accessible parking special account shall
2 be expended to cover the costs to administer the statewide
3 parking program for persons with disabilities under part III of
4 chapter 291."

5 SECTION 3. Section 249-31, Hawaii Revised Statutes, is
6 amended to read as follows:

7 "**§249-31 State registration fee.** (a) All vehicles and
8 motor vehicles in the [~~State as defined in section 249-1~~] state,
9 including antique motor vehicles, except as otherwise provided
10 in sections 249-4 and 249-6, shall be subject to a [~~\$25~~] \$26
11 annual vehicle registration fee. The fee shall be paid each
12 year together with all other taxes and fees levied by this
13 chapter on a staggered basis as established by each county as
14 [~~authorized~~] required by section 286-51, and the state
15 registration for that county shall likewise be staggered so that
16 the state registration fee is due and payable at the same time
17 and shall be collected together with the county fee. The state
18 registration fee shall be deemed delinquent if not paid with the
19 county registration fee. The respective counties shall collect
20 this fee together with the vehicle registration tax collected
21 for the county and shall transfer the moneys collected under
22 this section to the State.



1 (b) From each annual motor vehicle registration fee, the
 2 director shall deposit \$20 into the state highway fund [~~and~~], \$5
 3 into the emergency medical services special fund[-], and \$1 into
 4 the accessible parking special account established pursuant to
 5 section 348F-A."

6 SECTION 4. In codifying the new section added by Section 2
 7 of this Act, the revisor of statutes shall substitute the
 8 appropriate section number for the letter used in designating
 9 the new section in this Act.

10 SECTION 5. Statutory material to be repealed is bracketed
 11 and stricken. New statutory material is underscored.

12 SECTION 6. This Act shall take effect on January 1, 2012.

Report Title:

Parking for Disabled Persons; Special Account

Description:

Creates an Accessible Parking Special Account within the Disability and Communication Access Board Special Fund. Increases the state vehicle registration fee by \$1, to be deposited into the Accessible Parking Special Account. Requires all costs associated with the statewide Parking Program for Persons with Disabilities to be appropriated from the Accessible Parking Special Account beginning July 1, 2012.
