SENATE CONCURRENT RESOLUTION

REQUESTING THE AUDITOR TO ASSESS THE SOCIAL AND FINANCIAL
EFFECTS OF REQUIRING HEALTH INSURERS TO PROVIDE COVERAGE
FOR PHYSICAL THERAPY FOR CHRONIC PAIN THAT IS PRESCRIBED BY
A BOARD-CERTIFIED SURGEON.

1 WHEREAS, patients who suffer chronic pain, who have
2 recurring injuries, or who have more than one injury within a
3 calendar year that requires physical therapy are currently
4 limited to receiving eight sessions of physical therapy per year
5 that is covered by health care insurance in the State; and
6

7 WHEREAS, these patients should be offered additional
8 physical therapy sessions only if prescribed by a board-
9 certified surgeon -- as opposed to a primary care
10 physician -- that is fully covered by health care insurance; and
11

12 WHEREAS, section 23-51, Hawaii Revised Statutes, requires
13 that "[b]efore any legislative measure that mandates health
14 insurance coverage for specific health services, specific
15 diseases, or certain providers of health care services as part
16 of individual or group health insurance policies, can be
17 considered, there shall be concurrent resolutions passed
18 requesting the auditor to prepare and submit to the legislature
19 a report that assesses both the social and financial effects of
20 the proposed mandated coverage"; and

22 WHEREAS, section 23-51 further provides that "[t]he
23 concurrent resolutions shall designate a specific legislative
24 bill that:

26 (1) Has been introduced in the legislature; and

28 (2) Includes, at a minimum, information identifying the:

30 (A) Specific health service, disease, or provider
31 that would be covered;

- (B) Extent of the coverage;
- (C) Target groups that would be covered;
- (D) Limits on utilization, if any; and
- (E) Standards of care.

For purposes of this part, mandated health insurance coverage shall not include mandated optionals"; and

WHEREAS, section 23-52, Hawaii Revised Statutes, further specifies the minimum information required for assessing the social and financial impact of the proposed health coverage mandate in the Auditor's report; and

WHEREAS, S.B. No. (2011) mandates coverage for physical therapy for chronic pain that is prescribed by a board-certified surgeon for all policies and contracts, hospital and medical service plan contracts, medical service corporation contracts, and health maintenance organization plans and contracts issued after December 31, 2011; and

WHEREAS, the Legislature believes that mandatory health insurance coverage for physical therapy for chronic pain, as provided in S.B. No. (2011), will substantially reduce illness and assist in the maintenance of good health for the people of this State; now, therefore,

BE IT RESOLVED by the Senate of the Twenty-sixth Legislature of the State of Hawaii, Regular Session of 2011, the House of Representatives concurring, that the Auditor is requested to conduct an impact assessment report, pursuant to sections 23-51 and 23-52, Hawaii Revised Statutes, of the social and financial impacts of mandating coverage for physical therapy for chronic pain that is prescribed by a board-certified surgeon for all policies and contracts, hospital and medical service plan contracts, medical service corporation contracts, and health maintenance organization plans and contracts issued after December 31, 2011, as provided in S.B. No. (2011); and

BE IT FURTHER RESOLVED that the Auditor is requested to submit findings and recommendations to the Legislature,

1 including any necessary implementing legislation, twenty days
2 prior to the convening of the Regular Session of 2012; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 Concurrent Resolution be transmitted to the Auditor and to the
6 Insurance Commissioner, who in turn is requested to transmit
7 copies to each insurer in the State that issues health insurance
8 policies.
