# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF THE ATTORNEY GENERAL.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. In November 2011, Honolulu will host the Asia-  
2 Pacific Economic Cooperation (APEC) Leaders Meeting. APEC is  
3 the premier forum for Asia-Pacific economies to discuss trade  
4 and investment issues. The President of the United States,  
5 heads of state, cabinet ministers, business leaders, government  
6 officials, and many others are expected to attend the APEC  
7 meeting.

8           It is imperative that the State of Hawaii provide a safe  
9 venue for the APEC meeting. The funding requested in this Act  
10 will support the department of the attorney general's efforts in  
11 planning for the event and provide funding for law enforcement  
12 personnel and their related operating and equipment costs, and  
13 computers and software, to ensure a successful and safe APEC  
14 meeting.

15           SECTION 2. There is appropriated out of the general  
16 revenues of the State of Hawaii the sum of \$ \_\_\_\_\_, or so  
17 much thereof as may be necessary for fiscal year 2011-2012, to  
18 carry out the purposes of this Act, including operating expenses

1 relating to the planning and operation of security services and  
2 activities for the 2011 Asia-Pacific Economic Cooperation  
3 Leaders Meeting in Honolulu, Hawaii.

4 The sum appropriated shall be expended by the department of  
5 the attorney general for the purposes of this Act.

6 SECTION 3. The Act shall take effect on July 1, 2011.

PURPOSE: The purpose of this bill is to appropriate funds to Department of the Attorney General to support its efforts in planning for the upcoming Asia-Pacific Economic Cooperation (APEC) Leaders Meeting that will be held in November 2011 in Honolulu.

MEANS: General fund appropriation.

JUSTIFICATION: APEC is the premier forum for Asia-Pacific economies to discuss trade and investment issues. The President of the United States and other high ranking foreign dignitaries and business leaders will be attending this meeting. The funding requested in this Act will support the department of the attorney general's efforts in planning for the event and provide funding for law enforcement personnel and their related operating and equipment costs, and computers and software, to ensure a successful and safe APEC meeting.

Impact on the public: This bill will be beneficial to the public in ensuring that the APEC meeting will be conducted in a safe environment.

Impact on the department and other agencies: The department, the Honolulu Police Department, the Department of Defense, the Department of Transportation (Harbor Security), the Department of Land and Natural Resources, Department of Public Safety, and other law enforcement agencies will be called upon to provide personnel and other support services for this event.
