**A BILL FOR AN ACT**

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. This Act is recommended by the governor for  
2 immediate passage in accordance with section 9 of article VII of  
3 the Constitution of the State of Hawaii.

4           SECTION 2. The purpose of this Act is to amend Act 191,  
5 Session Laws of Hawaii 2010, which appropriated moneys from the  
6 emergency and budget reserve fund to maintain the levels of  
7 programs determined to be essential to education, public health,  
8 and public welfare for fiscal year 2010-2011.

9           The existing language of certain of Act 191's  
10 appropriations makes it difficult to carry out the legislature's  
11 intention of awarding moneys to specific organizations. This  
12 Act provides technical corrections to Act 191 to permit the  
13 awarding of moneys to specified organizations and extends the  
14 lapse date of Act 191's appropriations from June 30, 2011 to  
15 June 30, 2012.

16           SECTION 3. Act 191, Session Laws of Hawaii 2010, is  
17 amended by amending sections 12, 16, 18, 19, 21, 22, 30, 32, 33,  
18 34, 35, 36, 38, 39 to read as follows:

1           "SECTION 12. There is appropriated out of the emergency  
2 and budget reserve fund of the State of Hawaii the sum of  
3 \$332,000 or so much thereof as may be necessary for fiscal year  
4 2010-2011 for the Waianae District Comprehensive Health and  
5 Hospital Board, Incorporated to support its emergency room  
6 services. This is a grant pursuant to chapter 42F, Hawaii  
7 Revised Statutes.

8           The sum appropriated shall be expended by the department of  
9 health for the purposes of this Act.

10          SECTION 16. There is appropriated out of the emergency and  
11 budget reserve fund of the State of Hawaii the sum of \$500,000  
12 or so much thereof as may be necessary for fiscal year 2010-2011  
13 for Kokua Kalihi Valley Comprehensive Family Services. This is  
14 a grant pursuant to chapter 42F, Hawaii Revised Statutes.

15          The sum appropriated shall be expended by the department of  
16 health for the purposes of this Act.

17          SECTION 18. There is appropriated out of the emergency and  
18 budget reserve fund of the State of Hawaii the sum of \$200,000  
19 or so much thereof as may be necessary for fiscal year 2010-2011  
20 for the Windward Spouse Abuse Shelter. This is a grant pursuant  
21 to chapter 42F, Hawaii Revised Statutes.

1 The sum appropriated shall be expended by the department of  
2 human services for the purposes of this Act.

3 SECTION 19. There is appropriated out of the emergency and  
4 budget reserve fund of the State of Hawaii the sum of \$200,000  
5 or so much thereof as may be necessary for fiscal year 2010-2011  
6 for the Blueprint for Change Program for Neighborhood Place  
7 Walk-in Centers. This is a grant pursuant to chapter 42F,  
8 Hawaii Revised Statutes.

9 The sum appropriated shall be expended by the department of  
10 human services for the purposes of this Act.

11 SECTION 21. There is appropriated out of the emergency and  
12 budget reserve fund of the State of Hawaii the sum of \$762,500  
13 or so much thereof as may be necessary for fiscal year 2010-2011  
14 to provide funding for grants pursuant to chapter 42F, Hawaii  
15 Revised Statutes, to support domestic violence shelters  
16 statewide[.] and to be distributed as follows:

3           The sum appropriated shall be expended by the department of  
4 human services for the purposes of this Act.

5           SECTION 22. There is appropriated out of the emergency and  
6 budget reserve fund of the State of Hawaii the sum of \$210,000  
7 for fiscal year 2010-2011 for the Hale Mahaolu for personal care  
8 services. This is a grant pursuant to chapter 42F, Hawaii  
9 Revised Statutes.

10           The sum appropriated shall be expended by the department of  
11 human services for the purposes of this Act.

12           SECTION 30. There is appropriated out of the emergency and  
13 budget reserve fund of the State of Hawaii the sum of \$200,000  
14 or so much thereof as may be necessary for fiscal year 2010-2011  
15 to Adult Friends for Youth for youth gang prevention and  
16 intervention services. This is a grant pursuant to chapter 42F,  
17 Hawaii Revised Statutes.

18           The sum appropriated shall be expended by the department of  
19 human services for the purposes of this Act.

20           SECTION 32. There is appropriated out of the emergency and  
21 budget reserve fund of the State of Hawaii the sum of \$200,000  
22 or so much thereof as may be necessary for fiscal year 2010-2011

1 for Volunteer Legal Services Hawaii to provide pro bono legal  
2 services for indigent persons. This is a grant pursuant to  
3 chapter 42F, Hawaii Revised Statutes.

4 The sum appropriated shall be expended by the judiciary for  
5 the purposes of this Act.

6 SECTION 33. There is appropriated out of the emergency and  
7 budget reserve fund of the State of Hawaii the sum of \$720,000  
8 or so much thereof as may be necessary for fiscal year 2010-2011  
9 for the Legal Aid Society of Hawaii to provide general civil  
10 legal services. This is a grant pursuant to chapter 42F, Hawaii  
11 Revised Statutes.

12 The sum appropriated shall be expended by the judiciary for  
13 the purposes of this Act.

14 SECTION 34. There is appropriated out of the emergency and  
15 budget reserve fund of the State of Hawaii the sum of \$282,000  
16 or so much thereof as may be necessary for fiscal year 2010-2011  
17 for the Hawaii Family Law Clinic to provide services to obtain  
18 temporary restraining orders. This is a grant pursuant to  
19 chapter 42F, Hawaii Revised Statutes.

20 The sum appropriated shall be expended by the judiciary for  
21 the purposes of this Act.

1 SECTION 35. There is appropriated out of the emergency and  
2 budget reserve fund of the State of Hawaii the sum of \$150,000  
3 or so much thereof as may be necessary for fiscal year 2010-2011  
4 for Catholic Charities Hawaii to provide intra-familial sex  
5 assault services. This is a grant pursuant to chapter 42F,  
6 Hawaii Revised Statutes.

7 The sum appropriated shall be expended by the judiciary for  
8 the purposes of this Act.

9 SECTION 36. There is appropriated out of the emergency and  
10 budget reserve fund of the State of Hawaii the sum of \$150,000  
11 or so much thereof as may be necessary for fiscal year 2010-2011  
12 for the Children's Alliance of Hawaii, Inc. to provide child sex  
13 assault services. This is a grant pursuant to chapter 42F,  
14 Hawaii Revised Statutes.

15 The sum appropriated shall be expended by the judiciary for  
16 the purposes of this Act.

17 SECTION 38. There is appropriated out of the emergency and  
18 budget reserve fund of the State of Hawaii the sum of \$75,000 or  
19 so much thereof as may be necessary for fiscal year 2010-2011 to  
20 the Young Men's Christian Association for the Weed and Seed  
21 Program. This is a grant pursuant to chapter 42F, Hawaii  
22 Revised Statutes.

1           The sum appropriated shall be expended by the department of  
2 labor and industrial relations for the purposes of this Act."

3           SECTION 39. There is appropriated out of the emergency and  
4 budget reserve fund of the State of Hawaii the sum of \$466,000  
5 or so much thereof as may be necessary for fiscal year 2010-2011  
6 for the Kapiolani Medical Center for Women and Children for the  
7 sex abuse treatment center for statewide sex assault services.  
8 This is a grant pursuant to chapter 42F, Hawaii Revised  
9 Statutes.

10           The sum appropriated shall be expended by the department of  
11 the attorney general for the purposes of this Act.

12           SECTION 4. Act 191, Session Laws of Hawaii 2010, is  
13 amended by adding a new section to read as follows:

14           SECTION 40A. Any unexpended or unencumbered balances of  
15 any appropriation made by this Act as of the close of business  
16 on June 30, 2011 shall not lapse; provided that all moneys from  
17 the appropriations that are unencumbered as of June 30, 2012,  
18 shall lapse to the emergency and budget reserve fund.

**Report Title:**

Relating to the Emergency and Budget Reserve Fund

**Description:**

Makes an emergency appropriation from the emergency and budget reserve fund and makes technical corrections to Act 191, Session Laws of 2010 to permit the awarding of moneys to specified organizations. Extends the lapse date of Act 191's appropriations from June 30, 2011 to June 30, 2012.

JUSTIFICATION SHEET

DEPARTMENT: Office of the Governor

TITLE: A BILL FOR AN ACT RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

PURPOSE: To amend Act 191, Session Laws of Hawaii 2010 to permit the awarding of moneys to specified organizations.

MEANS: Amends Act 191, Session Laws of Hawaii 2010, adding in language specifying Chapter 42F grants and extending the lapse date of appropriations made in Act 191, SLH 2010 to June 30, 2012.

JUSTIFICATION: The 2010 Regular Session of the Legislature appropriated funds from the emergency and budget reserve fund. This measure would clarify that these appropriations are grants pursuant to Chapter 42F, which will allow the awarding of money to those organizations specified in the original Act.

Impact on the public: The various organizations will be able to receive their funding in a timely manner. As these organizations provide services to the public, this funding will assist those most in need.

Impact on the department and other agencies: The expending agencies will have an easier and more expedient process of providing funds to the various organizations named in Act 191, SLH 2010.
