# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There is appropriated from the source of  
3 funding indicated below to the department of budget and finance,  
4 departmental administration and budget division (BUF 101), the  
5 following sums or so much thereof as may be necessary to fund  
6 for fiscal biennium 2011-2013, the Hawaii employer-union health  
7 benefits trust fund costs contained in the agreement negotiated  
8 with the exclusive bargaining representative of collective  
9 bargaining unit (6):

12 SECTION 2. Funds appropriated by this part shall be  
13 allotted by the director of finance to the appropriate state  
14 departments for expenditure in the respective fiscal year for  
15 the purposes of this part.

17 SECTION 3. There is appropriated from the source of  
18 funding indicated below to the department of budget and finance,



1 departmental administration and budget division (BUF 101), the  
 2 following sums or so much thereof as may be necessary to fund  
 3 for fiscal biennium 2011-2013, the Hawaii employer-union health  
 4 benefits trust fund costs authorized by chapter 89C, Hawaii  
 5 Revised Statutes, for state officers and employees excluded from  
 6 collective bargaining who belong to the same compensation plans  
 7 as those officers and employees within collective bargaining  
 8 unit (6):

11 SECTION 4. Funds appropriated by this part shall be  
 12 allotted by the director of finance to the appropriate state  
 13 departments for expenditure in the respective fiscal year for  
 14 the purposes of this part.

15 PART III

16 SECTION 5. Collective bargaining cost items and cost  
 17 adjustments provided in this Act for any officer or employee  
 18 whose compensation is paid, in whole or in part, from federal,  
 19 special, or other funds shall be paid wholly or proportionately,  
 20 as the case may be, from the respective funds.

21 SECTION 6. Funds appropriated or authorized by this Act  
 22 that are not expended or encumbered by the end of the fiscal



1 year for which the appropriation or authorization is made, shall  
2 lapse as of those dates.

3 SECTION 7. This Act shall take effect on July 1, 2011.
