There are appropriated or authorized from the sources of funding indicated below to the department of budget and finance, departmental administration and budget division (BUF 101), the following sums or so much thereof as may be necessary to fund for fiscal biennium 2011-2013 all collective bargaining cost items in the agreement negotiated with the exclusive bargaining representative of collective bargaining unit (13):

SECTION 14. Funds appropriated or authorized by this Act that are not expended or encumbered by the end of the fiscal year for which the appropriation or authorization is made, shall lapse as of those dates.

SECTION 15. This Act shall take effect on July 1, 2011..
