
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
DEPARTMENT OF WATER COUNTY OF KAUAI.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2011-2012.

5 To be expended by the county of Kauai:

6 A. Kilauea water system, Kauai
7 Kilauea school waterline fire
8 protection improvements.

9 Construction \$1,000,000

10 Total funding \$1,000,000

11 B. Wailua-Kapaa water systems, Kauai
12 Kapaa storage tank fire protection
13 improvements.
