
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF TRANSPORTATION TO ISSUE A REQUEST FOR PROPOSALS TO REPLACE THE EXISTING HIGHWAY LIGHTING SYSTEMS ON STATE ROADS WITH LIGHT-EMITTING DIODE (LED) LIGHTING SYSTEMS.

1 WHEREAS, the State must continue to pursue every
2 appropriate opportunity to decrease the use of electricity and
3 to reduce the costs of purchasing and maintaining critical
4 systems; and
5

6 WHEREAS, one of the most basic means of energy conservation
7 is updating existing lighting systems with more energy efficient
8 lighting devices; and
9

10 WHEREAS, a light-emitting diode, or LED, is a device that
11 converts energy to light; and
12

13 WHEREAS, compared to incandescent bulbs and compact
14 fluorescent lights, the LED is more energy efficient, lasts
15 longer, is more durable, and contains no mercury; and
16

17 WHEREAS, in addition to being good for the environment,
18 switching to energy efficient lighting in public lighting
19 systems may result in significant savings in electricity costs;
20 and

22 WHEREAS, the costs and reliability associated with light
23 emitting diode lighting systems have progressed to the point
24 that such lighting systems should be implemented on public
25 streets and highways; now, therefore,
26

27 BE IT RESOLVED by the House of Representatives of the
28 Twenty-sixth Legislature of the State of Hawaii, Regular Session
29 of 2011, the Senate concurring, that the Department of
30 Transportation is requested to issue a request for proposals to



1 replace the existing highway lighting systems on state highways
2 with light emitting diode lighting systems; provided that the
3 new systems are installed and maintained at no additional
4 initial or annual costs to the State or counties; and
5

6 BE IT FURTHER RESOLVED that the Department of
7 Transportation is requested to include key technical
8 requirements in its request for proposals, including but not
9 limited to the following:

- 11 (1) Longevity: using the ENERGY STAR® Manufacturer's
12 Guide for Qualifying Solid State Lighting Luminaires -
13 Version 2.0, the chip manufacturer's LM-80 data, and
14 the luminaire in-situ temperature measurement point
15 (ISTMP) test, an industry-accredited third party test
16 lab should determine the lumen maintenance at six
17 thousand hours for the proposed fixture; provided that
18 lumen maintenance is equal to or greater than ninety-
19 six per cent;
20
 - 21 (2) Reliability: published, third party laboratory
22 audited reliability data on all solid state lighting
23 fixtures manufactured for at least the past three
24 calendar years should show not less than ninety-eight
25 per cent of the solid state lighting fixtures are
26 still in operation from the first commercial solid
27 state lighting fixture shipped, or for the past three
28 years, whichever period is longer;

 - 30 (3) Efficiency: efficiency performance should exceed
31 sixty L/W;
32
 - 33 (4) Surge protection: the luminaires should be designed
34 to meet the surge immunity up to ten kVA, per
35 requirements specified in IEEE Standard C62.41.2
36 category B3 and C1;
37
 - 38 (5) Harmonic Distortion: the fixtures should be designed
39 for less than ten per cent total harmonic distortion,
40 per Federal Communications Commission Part 15 Subpart
41 B, Class B;
42
 - 43 (6) UL listed: all fixtures shipped by the manufacturer
44 should be UL listed;

2 (7) Lighting Facts: fixtures submitted should be listed
3 on United States Department of Energy's Lighting Facts
4 website and have a Lighting Facts Label;
5
6 (8) Field serviceable: the internal components of the
7 fixtures should be able to be replaced in the field;
8
9 (9) Warranty: minimum five year warranty to cover one
10 hundred per cent of all luminaire components and the
11 individual LED chips;
12
13 (10) Made in America: fixtures shipped to this
14 specification should be American Recovery and
15 Reenactment Act compliant and contain no more than
16 five per cent non-United States sourced components;
17
18 (11) Wireless Monitoring and Management: all wireless
19 control should be designed to be managed on the
20 secondary side of the fixture circuitry, to protect
21 from surges and spikes; and
22
23 (12) Full monitoring and Control Capabilities: fixtures
24 should include an Internet Protocol-addressable chip
25 that allows individual remote monitoring and full
26 dimming capabilities; and
27

28 BE IT FURTHER RESOLVED that, in order to ensure that the
29 new lighting systems are installed at no expense to the State,
30 will not increase annual maintenance and operating costs to the
31 State, and will encourage job growth; the Department of
32 Transportation is requested to include the following non-
33 technical requirements in its request for proposals:
34

- 35 (1) Requiring the bidder to offer, at a minimum, a cost
36 neutral program for the State to replace existing
37 street lights with LED street lights, with the intent
38 of creating a net positive cash flow each fiscal year;

40 (2) Requiring the bidder to provide a guarantee to the
41 State that the LED lights will perform to the
42 manufacturer's specification for the entire length of
43 the term of the project;

(3) Requiring the bidder to use residents of the State to handle all logistics for the implementation of the project, and throughout the guaranteed period; and

(4) Requiring the bidder to maintain, for the duration of the project, a local source for any and all components of the fixtures in the event of any failures; and

BE IT FURTHER RESOLVED that a certified copy of this Concurrent Resolution be transmitted to the Director of Transportation.
