## HOUSE RESOLUTION

URGING THE CITY AND COUNTY OF HONOLULU TO COMPLETE THE  
IMPLEMENTATION OF SALT LAKE DISTRICT PARK MASTER PLAN.

1           WHEREAS, Salt Lake is a suburban neighborhood of Honolulu  
2 that was developed in the 1960s during a construction boom; and  
3

4           WHEREAS, in its early years, Salt Lake provided residents  
5 with a view of downtown Honolulu and the sugar plantations of  
6 central Oahu; and  
7

8           WHEREAS, currently, Salt Lake is commonly known for its  
9 high-rise condominiums and townhouses, and homes; and  
10

11           WHEREAS, in addition to the various types of housing, the  
12 Salt Lake community is also endowed with large stretches of park  
13 lands, a freshwater lake, and a country club; and  
14

15           WHEREAS, residents and visitors of the Salt Lake and  
16 Moanalua communities enjoy and appreciate the beauty and  
17 recreation provided by its parks; and  
18

19           WHEREAS, in the 1980s, Salt Lake District Park was  
20 developed as a multi-use recreational facility with playing  
21 fields as well as a gymnasium, swimming pool, and meeting rooms,  
22 although not all of those improvements were completed; and  
23

24           WHEREAS, the original Salt Lake District Park Master Plan  
25 included a walking and biking trail connecting the Salt Lake  
26 District Park to the Ala Puumalu Community Park; and  
27

28           WHEREAS, in 2002, an update to the Salt Lake District Park  
29 Master Plan addressed deficiencies in existing park facilities  
30 and proposed development of new facilities; and

32           WHEREAS, the Salt Lake District Park Master Plan has yet to  
33 be completed; now, therefore,




1 BE IT RESOLVED by the House of Representatives of the  
2 Twenty-sixth Legislature of the State of Hawaii, Regular Session  
3 of 2011, that the City and County of Honolulu is urged to  
4 complete the implementation of the Salt Lake District Park  
5 Master Plan; and

7 BE IT FURTHER RESOLVED that the City and County of Honolulu  
8 is requested to report its progress to the Legislature no later  
9 than 20 days prior to the convening of the Regular Session of  
10 2012; and

12 BE IT FURTHER RESOLVED that certified copies of this  
13 Resolution be transmitted to the Mayor of the City and County of  
14 Honolulu, Director of the City and County of Honolulu Department  
15 of Parks and Recreation, and the Chairperson of the Aliamanu/Salt  
16 Lake/Foster Village Neighborhood Board No. 18.
