## HOUSE RESOLUTION

## REQUESTING THE AUDITOR TO REVIEW STATE EXECUTIVE BRANCH PRACTICES IN DETERMINING WHETHER TO RELEASE FUNDS APPROPRIATED BY THE LEGISLATURE.

WHEREAS, Molokai General Hospital, founded in 1962, and 1 Molokai Community Health Center, which opened in 2004, both 2 3 serve the island's seven thousand residents; and 4 WHEREAS, in January 2011, the Molokai Community Health 5 Center stopped construction on its facility at a six-acre site 6 in Kaunakakai because the State failed to release \$1,000,000 7 8 needed to continue the project; and 9 WHEREAS, Molokai Community Health Center, which now 10 operates out of three separate sites, has invested \$1,400,000 to 11 expand its services by building a larger facility in Kaunakakai; 12 and 13 14 WHEREAS, according to the Department of Health, the 15 previous state administration delayed releasing the funds that 16 the Legislature appropriated in 2009 for the Molokai Community 17 Health Center because of budget constraints; and 18 19 WHEREAS, however, some believe that resistance by Molokai 20 General Hospital, part of The Queen's Health Systems, to the 21 expansion of Molokai Community Health Center may have held up 22 release of those funds; and 23 24 25 WHEREAS, there are concerns that Molokai General Hospital and Molokai Community Health Center will duplicate health 26 27 services and compete for patients and funds; and 28 29 WHEREAS, the president of Molokai General Hospital was a 30 member of the previous state administration's Department of Health Advisory Committee while the Molokai Community Health 31 Center fought for the money to be released; and 32 33





1 WHEREAS, although the current state administration has 2 indicated that it will release the funds needed to complete the 3 expansion of Molokai Community Health Center, greater 4 transparency in the decision to release or withhold appropriated 5 funds would resolve uncertainties and increase public confidence; now, therefore, 6 7

8 BE IT RESOLVED by the House of Representatives of the 9 Twenty-sixth Legislature of the State of Hawaii, Regular Session of 2011, that the Auditor is requested to review the policies 10 11 and procedures of the state executive branch in determining whether to release funds appropriated by the Legislature; and 12 13

14 BE IT FURTHER RESOLVED that the Auditor is requested to focus its review on the initial decision of the previous state 15 16 administration to withhold funds appropriated in 2009 for the expansion of the Molokai Community Health Center; and 17 18

19 BE IT FURTHER RESOLVED that the Auditor is requested to 20 submit its findings and recommendations to the Legislature no later than twenty days prior to the convening of the Regular 21 Session of 2012; and 22

24 BE IT FURTHER RESOLVED that certified copies of this Resolution be transmitted to the Governor, the Director of 25 Health, the Auditor, the Executive Director of Molokai Community 26 Health Center, and the President of Molokai General Hospital. 27
