## HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF HAWAIIAN HOME LANDS TO ESTABLISH A GAMING TASK FORCE TO STUDY THE ECONOMIC AND SOCIAL IMPACTS OF ALLOWING GAMING AND ESTABLISHING CASINO OPERATIONS ON HAWAIIAN HOME LANDS.

1 WHEREAS, the Department of Hawaiian Home Lands is exploring 2 options to establish a consistent and sustainable cash flow to financially support its programs; and 3 4 WHEREAS, many destinations that are competing with Hawaii 5 for visitor dollars have legal gaming in some form; and 6 7 8 WHEREAS, Hawaii is one of only two states that prohibit all 9 types of gaming; and 10 11 WHEREAS, those opposed to legal gaming argue that these forms of gaming will not attract new dollars from outside 12 Hawaii, but instead will cause a shift in spending patterns, 13 which will ultimately be detrimental to local residents; and 14 15 WHEREAS, on the other hand, proponents of gaming argue that 16 the State loses millions in revenue each year to other 17 jurisdictions that allow gaming; now, therefore, 18 19 BE IT RESOLVED by the House of Representatives of the 20 Twenty-sixth Legislature of the State of Hawaii, Regular Session 21 of 2011, that the Department of Hawaiian Home Lands is requested 22 to establish a Gaming Task Force to study the advantages and 23 disadvantages, including but not limited to economic and social 24 impacts, of allowing gaming and establishing casino operations 25 on Hawaiian home lands; and 26 27 BE IT FURTHER RESOLVED that the Task Force is requested to 28 29 include the following members: 30 31 (1)The Chairperson of the Hawaiian Homes Commission or the Chairperson's designee; 32 33

The Director of Business, Economic Development, and 1 (2) 2 Tourism or the Director's designee; 3 4 The Director of Commerce and Consumer Affairs or the (3) Director's designee; 5 6 7 (4) The Chairperson of the Board of Directors of the 8 Hawaiian Tourism Authority or the Chairperson's 9 designee; and 10 The Chairperson of the Board of Directors of the (5) 11 Hawaii Visitors and Convention Bureau or the 12 Chairperson's designee; and 13 14 15 BE IT FURTHER RESOLVED that the members of the Task Force shall select a chairperson from among themselves; and 16 17 BE IT FURTHER RESOLVED that the Task Force is requested to 18 submit a report of its findings and recommendations, including 19 any proposed legislation, to the Legislature no later than 20 twenty days prior to the convening of the Regular Session of 21 2012; and 22 23 24 BE IT FURTHER RESOLVED that certified copies of this 25 Resolution be transmitted to the Chairperson of the Hawaiian Homes Commission; Director of Business, Economic Development, 26 27 and Tourism; Director of Commerce and Consumer Affairs; Chairperson of the Board of Directors of the Hawaiian Tourism 28 29 Authority; and Chairperson of the Board of Directors of the Hawaii Visitors and Convention Bureau. 30 31 32
