# A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 **PART I**

2 SECTION 1. There is appropriated or authorized from the  
3 sources of funding indicated below to Hawaii employer-union  
4 health benefits trust fund (BUF 761) the following sums or so  
5 much thereof as may be necessary to fund for fiscal biennium  
6 2011-2013, the Hawaii employer-union health benefits trust fund  
7 costs contained in the collective bargaining agreement  
8 negotiated with the exclusive bargaining representative of  
9 collective bargaining unit (6):

12 SECTION 2. Funds appropriated or authorized by this part  
13 shall be allotted by the director of finance to the appropriate  
14 state departments for expenditure in the respective fiscal year  
15 for the purposes of this part.

17 SECTION 3. There is appropriated or authorized from the  
18 sources of funding indicated below to Hawaii employer-union



1 health benefits trust fund (BUF 761) the following sums or so  
 2 much thereof as may be necessary to fund for fiscal biennium  
 3 2011-2013, the Hawaii employer-union health benefits trust fund  
 4 costs authorized by chapter 89C, Hawaii Revised Statutes, for  
 5 state officers and employees in the executive branch who are  
 6 excluded from collective bargaining and belong to the same  
 7 compensation plans as those officers and employees within  
 8 bargaining unit (6):

11 SECTION 4. Funds appropriated or authorized by this part  
 12 shall be allotted by the director of finance to the appropriate  
 13 state departments for expenditure in the respective fiscal year

16 SECTION 5. Funds appropriated or authorized by this Act  
 17 that are not expended or encumbered by June 30, 2012, and  
 18 June 30, 2013, of the respective fiscal years, shall lapse as of  
 19 those dates.

20 SECTION 6. This Act shall take effect on July 1, 2011.
