A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 **PART I**

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to program planning,
4 analysis, and budgeting (BUF 101) the following sums or so much
5 thereof as may be necessary to fund for fiscal biennium 2011-
6 2013, the Hawaii employer-union health benefits trust fund costs
7 in the agreements negotiated with the exclusive bargaining
8 representatives of collective bargaining unit (3):

11 SECTION 2. Funds appropriated or authorized by this part
12 shall be allotted by the director of finance to the appropriate
13 state departments in the respective fiscal year for the purposes

16 SECTION 3. There are appropriated or authorized from the
17 sources of funding indicated below to program planning,
18 analysis, and budgeting (BUF 101) the following sums or so much



1 thereof as may be necessary to fund for fiscal biennium 2011-
 2 2013, the Hawaii employer-union health benefits trust fund costs
 3 for state officers and employees in the executive branch who are
 4 excluded from collective bargaining:

 8 shall be allotted by the director of finance to the appropriate

12 SECTION 5. Salary increase and cost adjustments provided
 13 in this Act for any officer or employee whose compensation is
 14 paid, in whole or in part, from federal, special, or other funds
 15 shall be paid wholly or proportionately, as the case may be,
 16 from the respective funds.

17 SECTION 6. Funds appropriated or authorized by this Act
 18 that are not expended or encumbered by June 30, 2011, and
 19 June 30, 2012, of the respective fiscal years, shall lapse as of
 20 those dates.
