Your Committee on Health, to which was referred H.B. No. 602
entitled:

"A BILL FOR AN ACT MAKING AN APPROPRIATION FOR CERVICAL AND
BREAST CANCER SCREENING,"

begs leave to report as follows:

The purpose of this bill is to reach more women who are
eligible to be screened for breast and cervical cancer under the
Hawaii Breast and Cervical Cancer Control Program, which makes
screening services available to low-income, uninsured, and
underserved women, by making an appropriation for such screening.

Planned Parenthood of Hawaii, the Hawaii Chapter of the
American Physical Therapy Association, the American Cancer
Society, Healthy Mothers Healthy Babies Coalition and numerous
individuals supported this bill. The Department of Health
supported the intent of the measure.

Your Committee finds that women who live in poverty as well
as racial and ethnic minorities have a higher rate of cancer-
related deaths due to a variety of barriers including economic.
Early detection through screening is critical in saving lives.


As affirmed by the record of votes of the members of your
