Your Committees on Water, Land, & Ocean Resources and
Hawaiian Affairs, to which was referred H.B. No. 948 entitled:

"A BILL FOR AN ACT RELATING TO CEDED LANDS,"

beg leave to report as follows:

The purpose of this bill is to require the Department of Land
and Natural Resources (DLNR) to conduct an audit of all state-held
lands and develop an inventory of ceded lands in the State, and to
report its findings to the Legislature no later than 20 days prior
to the convening of the Regular Session of 2012.

The Association of Hawaiian Civic Clubs and several concerned
individuals testified in support of this bill. The Office of
Hawaiian Affairs supported this measure with amendments. The
Department of Land and Natural Resources opposed this bill.


As affirmed by the records of votes of the members of your
Committees on Water, Land, & Ocean Resources and Hawaiian Affairs
that are attached to this report, your Committees are in accord
with the intent and purpose of H.B. No. 948 and recommend that it
pass Second Reading and be referred to the Committee on Finance.
