Your Committee on Housing, to which was referred H.C.R. No. 142 entitled:

"HOUSE CONCURRENT RESOLUTION URGING HAWAII TELEVISION, RADIO AND PRINT MEDIA OUTLETS TO ADDRESS THE "NOT IN MY BACK YARD" (NIMBY) ATTITUDE IN HAWAII,"


