Your Committee on International Affairs, to which was referred H.C.R. No. 150 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE CITY AND COUNTY OF HONOLULU TO COMPLETE NECESSARY ASIA-PACIFIC ECONOMIC COOPERATION-RELATED PUBLIC WORKS PROJECTS BEFORE THE COMMENCEMENT OF THE ASIA-PACIFIC ECONOMIC COOPERATION SUMMIT,"
