Your Committee on Finance, to which was referred H.C.R. No. 264 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO CONDUCT A STUDY OF PRIVATE BOATING FACILITIES STATEWIDE AND DETERMINE THE FEASIBILITY OF GENERATING ADDITIONAL REVENUES FROM COMMERCIAL OPERATIONS OCCURRING AT OR FROM THESE FACILITIES,"
